BACKGROUND

- Extension of Infrastructure Sales Tax was approved by the voters in November 2015
- Term of levy from January 1, 2018, to December 31, 2032 (15 years)
- Distributed evenly among the County (1/3), the School Board (1/3), and all the municipalities (1/3)



BACKGROUND

- Referendum included these categories:
 - Public Safety: Law Enforcement Vehicles, Fire Trucks and Ambulances, and Public Safety Equipment
 - Quality of Life: Parks, Trails, Recreation, and Libraries
 - Public Works: Roads, Sidewalks, Transportation, Water Quality, Utilities, and Drainage Improvements
 - Other Public Infrastructure
