TAKE ADVANTAGE OF THE PRIMARY CARE CONNECTION-EMPLOYEE HEALTH AND WELLNESS CENTER

Services through the Wellness Center are free for anyone covered under the Lake County health plan, including dependents ages two and older. Center staff are board certified and can diagnose, treat, and prescribe medications. Center staff can also dispense common generics for free.

What you need to know

- The PCC can be used as your primary care service, or in conjunction with your current primary care doctor.
- You can use the PCC for lab services at a lower cost and the results can be sent to your physician prior to your visit.
- Skip the pharmacy! Prescriptions for common generic medications will be dispensed directly at the PCC after you've seen the doctor.
- Free annual wellness exams can help to catch medical problems early, and regular visits may improve the management of chronic disease.
- Your health information will be kept private and confidential and cannot be shared with your employer, unless you are receiving treatment for a work-related injury.

Plan Name	Description
Hospital Indemnity Insurance	Provides cash benefits directly to the insured that help pay for some of the costs associated with a covered hospital stay due to a sickness or accidental injury.
Critical Illness	Provides cash benefits when an insured is diagnosed with a covered critical illness. Provides a lump sum payment to help with out-of-pocket medical expenses.
Group Accident	Provides cash benefits to the employee that can help with out of pocket expenses associated with treatment in the event of a covered accident.

FLEXIBLE SPENDING SAVES MONEY ON YOUR TAXES

It's as easy as swiping a card when it comes to saving on out-of-pocket costs. And this year, your flexible spending has increased from \$2,650 to \$2,700 for health care. Flexible spending accounts (FSA) help employees to save taxes on money spent for healthcare expenses. An FSA allows you to save up to 30 percent on your eligible healthcare expenses every year by using pre-tax dollars. The money put into an FSA is tax-free, but must be used on approved healthcare-related costs.

PHARMACY CHANGES

Medical plans across the nation have seen major increases in charges related to prescription costs. Florida Blue will be changing our prescription program (effective 10/1/2019) in the following ways:









Participants will no longer be able to fill prescriptions through the plan at CVS or Target pharmacies. Prescriptions will still be covered under the plan at other current providers like Publix, Walgreens, and Winn-Dixie. Participants also have access to Florida Blue Prime Therapeutics Mail-Order prescription service. See below for more information. To search for pharmacy providers, visit www.floridablue.com.

★ The pharmacy must fill a generic. However, employees who prefer a brand when a generic is available will pay the difference in cost between the brand and the generic along with any applicable member cost share.
