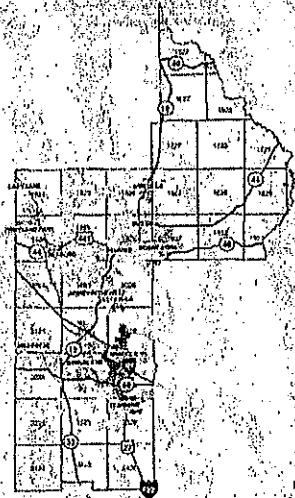

A public hearing on the ordinance to transmit the proposed 2030 Comprehensive Plan to the State of Florida Department of Community Affairs will be held at 9:00 a.m., or soon thereafter, on Tuesday, January 19th, 2010 (If necessary, the hearing will continue on Wednesday, January 20, 2010 at 1:00 p.m.), in the County Commissioners Chambers, 2nd Floor, Round Administration Building, 315 West Main Street, Tavares, Florida.

The proposed 2030 Comprehensive Plan shall be available for review at the Lake County Department of Growth Management, Planning & Community Design Division, 5th Floor - Administration Building - Room #510, between the hours of 8:00 a.m. and 5:00 p.m., Monday through Friday, at least ten (10) days prior to the hearing.

Interested parties may appear at the hearing and be heard with respect to the proposed Ordinance.
