### 1. Need for Project:

The purpose of this Project Development and Environment (PD&E) Study is to evaluate alternatives for a new interchange at a future unnamed road and Florida's Turnpike within proximity of Florida's Turnpike Mile Post 279, Lake County, Florida. The new interchange would be located within the right-of-way provided by The Hills of Minneola, a proposed mixed-use community located just north of State Road 50 and east of U.S. 27. The PD&E Study is being conducted by the Family Dynamics Land Company, LLC in consultation with the Florida's Turnpike Enterprise.

Around the 1990s, the Cities of Minneola and Clermont began to experience significant population growth which continues at a steady rate. For example, in addition to the Hills of Minneola, there are several additional mixed-use developments located within a one-mile radius of the proposed new interchange. Overall estimates for new residential units in the immediate area are expected to exceed 10,000 single and multi-family units. With this steady increase in housing developments, office/retail uses and other public realm amenities, escalating travel demands are being placed on the existing transportation network at an alarming rate.

The existing transportation network, which consists primarily of rural two lane collectors and two major arterials, U.S. 27 (north-south) and State Road 50 (east-west), is unable to adequately address future transportation needs. With limited funds available for roadway network expansion, improvements, such as road widening(s) and/or the construction of new arterials, collectors and frontage roads are slow to materialize due to limited construction resources.

Lake County Government and Florida's Turnpike Enterprise conducted the following studies that concluded that a new interchange within the proximity to Mile Post 279 is needed to improve regional and local mobility and accommodate future travel demands.

- Lake County Minneola Ridge Area-Wide Traffic Study Lake County Department of Public Works
- Lake County Area Access Plan Florida's Turnpike Enterprise
- Lake-Sumter MPO 2025 Long Range Transportation Plan

#### 2. Description of Project:

The new interchange would be located approximately halfway between the existing interchanges at U.S. 27 and State Road 50, with each being about six miles away. New on-site roads as well as off-site road extensions will be constructed by others, not a part of this PD&E, in order to integrate the new interchange into the area's road system. The surrounding municipalities and Lake County are currently working

with area land owners and developers to finalize joint partnerships and identify potential funding sources for roadway improvement projects. The project limits for the proposed interchange is along a section of the existing Florida's Turnpike near Mile Post 279.

This PD&E study is being conducted to evaluate alternatives for the Minneola Interchange with Florida's Turnpike at Mile Post 279 in Lake County. The "no-build" alternative will be considered throughout the PD&E process.

#### 3. Environmental Information:

- a. Land Uses: The new interchange site is located within a proposed Development of Regional Impact (DRI) called The Hills of Minneola. The interchange site is located along the existing Florida's Turnpike and is primarily comprised of undeveloped upland communities consisting of pine plantations.
- b. Wetlands: The potential for impacts to jurisdictional wetlands associated with the development of the proposed interchange is minimal. Based on current information, no connected wetlands would be impacted by the proposed interchange. Wetland areas within the project corridor will be identified by evaluating existing information such as aerial photography, United States Department of Agriculture/Soil Conservation Service mapped soils, appropriate water management district and/or National Wetland Inventory land use mapping and United States Geologic Survey topographic contours coupled with selective groundtruthing. Any potential wetland impacts will be coordinated with the appropriate regulatory agencies and compensatory mitigation will be provided.
- c. Floodplains: According to the Flood Insurance Rate Maps, the proposed project may involve work in areas of the 100-year floodplain. Therefore, impacts to floodplains and regulatory floodways will be assessed as part of this study.
- d. Wildlife and Habitat: Impacts to Threatened and Endangered species due to the development of the probable interchange configuration is also anticipated to be minimal as the footprint of development appears to lie wholly in planted pine plantation. A wildlife and habitat assessment will be conducted to evaluate the potential for any impacts to listed species during the study. The assessment will include collecting information from the U.S. Fish and Wildlife Service, the Florida Fish and Wildlife Conservation Commission, and the Florida Natural Areas Inventory database. Any known listed species populations within or adjacent to the right-of-way will be groundtruthed and recorded for formal coordination with the appropriate regulatory agencies and compensatory mitigation will be provided, as required.




Figure 1
