KNOW ALL MEN BY THESE PRESENTS, That the undersigned, in consideration of the sum of One Dollar and other valuable considerations, the receipt of which is hereby acknowledged, grants and conveys to FLORIDA POWER CORPORATION, its successors and assignces, the right, privilege and easement to construct, operate and maintain for such period of time as it may use the same or until the use thereof is abandoned, a single pole, HETAME XICLUSTICS line for the transmission and distribution of electricity, including necessary communication and other wires, poles, guys, anchors, ground connections, attachments, fixtures, equipment and accessories desirable in connection therewith over, upon and across the following described land in Lake County, State of Florida, to wit: (a) No of Govt. Lot 1 and E. 660 ft. of G.L. 2, also known as E. 4 of N. 1 of NE 1; Sec. 12, Twp. 22 S, Rng. 25E, thru which the center line of the power line is to run approx. parallel with and not more, than 15' south of the N. boundary of Lot 1. (b) NF 1 of SE 2, Sec. 33; No of SW 2 and NE 2 of SE 1, Sec. 34; also NW 1 of SW 1, Sec. 35, all in T21 S. R25 E., center line of the power line to conform with rows of citrus trees and be approx. parallel to and 15' from the 40 acre boundaries. Clearing is restricted to 50 ft, on each side of C/L of power line, plus danger trees.
