FAITHFUL PERFORMANCE BOND

KNOW ALL MEN BY THESE PRESENTS, That we, **Shea Homes Active Adult, LLC**, as Principal, and **Westchester Fire Insurance Company**, as Surety, are held and firmly bound unto **City of Groveland**, **Florida**, as Obligee, in the sum of **One Million Five Hundred Fifty Thousand Seven Hundred Seventy and 49/100 Dollars (\$1,550,770.49)**, lawful money of the United States, for the payment of which sum well and truly to be made, we bind ourselves jointly and severally, firmly by these presents.

THE CONDITION OF THE FOREGOING OBLIGATION IS SUCH, That, Whereas, said Principal agrees to construct the following public utility improvements in the Subdivision known as Cascades of Groveland -Trilogy Phase 5:

Sanitary Sewer, Water and Reclaimed Water Facilities according to the approved Plans and Specifications prepared by Dewberry Engineers, Inc.

and, as a condition of approving said Subdivision Final Plat, the Principal is required to give a bond to guarantee completion of said improvements.

It is hereby understood and agreed that this Bond shall be enforceable at the sole discretion of the Obligee. In the event that any of said improvements have not been installed or completed as provided herein, the Obligee may declare, in its sole discretion, the Principal to be in default of the conditions of this Bond. The decision of the Obligee shall be binding.

Whenever Obligee shall declare Principal in default of the provisions of this Bond and shall promptly notify Surety of such default, Surety shall, within 30 days do one of the following, in consultation with the Obligee:

- a. Begin to complete the work required under the terms of this Bond in accordance with the approved plans and specifications referenced above using a contractor or subcontractor agreed to by the Obligee;
- b. Tender a replacement contractor agreed to by the Obligee to complete the work required under the terms of this Bond in accordance with the approved plans and specifications referenced above; or
- c. In consultation with the Obligee, determine the cost to complete the work in this Bond and tender to Obligee funds in the amount of such cost.

Notice shall be given in writing to the Surety at:

NOW, THEREFORE, if the said Principal shall well and truly do and perform all the covenants and obligations of said agreement on its part to be done and performed at the time and in the manner specified therein, then this obligation shall be null and void; otherwise, it shall be and remain in full force and effect and, in addition, Surety agrees to pay reasonable attorneys' fees and costs, including engineers fees, in the event that it becomes necessary to bring an action to enforce this bond.

Governing Law/Venue and Jurisdiction: This Bond shall be governed by the laws of the state of Florida without regard to conflicts of law provisions. Venue of any litigation arising out of this Bond shall be only within any court of competent jurisdiction regularly sitting in Lake County, Florida
