LANE CLOSURES: From Sunday, February 3 to Thursday February 7, Florida's Turnpike northbound entrance ramp from CR 470 (Exit 296), will close nightly until 5 a.m. CR 470 westbound traffic to Florida's Turnpike northbound will continue west to CR 501, then travel north to CR 468, then west to US 301, then north to Florida's Turnpike. CR 470 eastbound traffic to Florida's Turnpike northbound will continue east to US 27, then travel south to Florida's Turnpike.

Florida's Turnpike northbound from Milepost 288.5 to Milepost 290 will have a single lane closure, around-the-clock beginning at 6 p.m., Monday, February 4 and continuing until 8:30 a.m., Thursday, February 7. Intermittent single lane closures are anticipated through the duration of the project.

LANE CLOSURES: On Thursday, February 7, all I-75 southbound at SR 44 lanes will close from 12:30 a.m. to 4:30 a.m. Southbound I-75 traffic to Florida's Turnpike southbound will exit I-75 at SR 44 and travel east to US 301, then south to Florida's Turnpike. Traffic continuing to I-75 southbound will exit at SR 44 and travel east to US 301, then continue south to CR 470, then west to return to I-75 southbound. There are anticipated intermittent night time lane closures through the duration of the project.
