Let me begin by thanking the Lake~Sumter Metropolitan Planning Organization for prioritizing last year as the top right of way project Groveland's SR 50 Realignment Project. This transformational project will not only correct a major operational bottleneck while enhancing freight movement, it also will allow Groveland's historic downtown to redevelop and will include Phase 3C of the South Lake Trail, also part of the Coast to Coast Trail.

As the Lake~Sumter MPO begins this month the annual process of adopting the *List of Priority Projects*, Groveland appreciates remaining atop of the Right of Way Projects table. Last year, the MPO approved a special table at the request of the Florida Department of Transportation (FDOT). It was the "Top 15 Priority Projects." On that table, the project was listed at #5 and Groveland is appreciative of that ranking.

This year, a prioritization of #1 of the SR 50 Realignment Project on the MPO's special table of the *List of Priority Projects* will afford the project special opportunities.
