Please be advised that a tree removal permit must be submitted and approved prior to the removal of any trees.

Fire and Building Safety

Please be advised that in accordance with the Florida Fire Prevention Code: 6.2 Portable Fire Extinguishers.
 6.2.1 Placement., 6.2.1.1 - Placement of portable fire extinguishers shall be in accordance with Chapter 5 of NFPA 10, Standard for Portable Fire Extinguishers, unless otherwise permitted by 6.2.1.1.1, 6.2.1.1.2, or 6.2.1.1.3.

- B. 6.2.1.1.1 Placement of portable fire extinguishers on piers and along bulkheads where vessels are moored or are permitted to be moored shall meet the following criteria:
 - (1) Extinguishers listed for Class A, Class B, and Class C fires shall be installed at the pier/land intersection on a pier that exceeds 25 ft (7.62 m) in length.
 - (2) Additional fire extinguishers shall be placed such that the maximum travel distance to an extinguisher does not exceed 75 ft (22.86 m).
