## Summary of Ordinance

The purpose of this ordinance is to amend Section 8-2, Lake County Code, entitled *Jurisdiction and Powers*, and create Section 14.00.13, Land Development Regulations, to clarify that the code enforcement special master may enforce restrictions contained on site plans, plats, or other development orders approved under the Land Development Regulations.

Changes are shown as follows: Strikethrough for deletions and <u>Underline</u> for additions to existing Code sections. The notation "\* \* " shall mean that all preceding or subsequent text remains unchanged (excluding any renumbering or relettering that might be needed).

## ORDINANCE NO. 2019-

AN ORDINANCE OF THE BOARD OF COUNTY COMMISSIONERS OF LAKE COUNTY, FLORIDA; AMENDING SECTION 8-2, LAKE COUNTY CODE, ENTITLED JURISDICTION AND POWERS; CREATING SECTION 14.00.13, LAKE COUNTY CODE, APPENDIX E, LAND DEVELOPMENT REGULATIONS, TO BE ENTITLED ACTION BY THE LAKE COUNTY CODE ENFORCEMENT SPECIAL MASTER; CLARIFYING THAT THE CODE ENFORCEMENT SPECIAL MASTER HAS AUTHORITY TO ENFORCE RESTRICTIONS ON ANY DEVELOPMENT ORDER APPROVED UNDER THE LAND DEVELOPMENT REGULATIONS; PROVIDING FOR SEVERABILITY; PROVIDING FOR INCLUSION IN THE CODE; PROVIDING FOR FILING WITH THE DEPARTMENT OF STATE; AND PROVIDING FOR AN EFFECTIVE DATE.

**WHEREAS,** Chapter 8, Lake County Code, establishes the jurisdiction and powers of the code enforcement special master; and

**WHEREAS**, the code enforcement special master is an effective and cost-saving mechanism used to enforce local codes, development orders, and regulations; and

**WHEREAS,** the Board desires to clarify that the special master has the jurisdiction and power to enforce any restrictions, notes, requirements, terms or conditions contained within any development order issued under the Land Development Regulations, including approved site plans and plats; and

**WHEREAS**, the amendments and modifications contained herein are in the best interest of the residents of Lake County, Florida.

**NOW, THEREFORE, BE IT ORDAINED** by the Board of County Commissioners of Lake County, Florida as follows:

**Section 1.** Recitals. The foregoing recitals are true and correct and incorporated herein by reference.

 **Section 2.** <u>Amendment.</u> Section 8-2, Lake County Code, entitled *Jurisdiction and Powers*, is hereby amended to read as follows:

## Sec. 8-2. Jurisdiction and powers.

The code enforcement special master shall have jurisdiction to hear and decide cases involving an alleged violation or breach of any provision, term and/or condition of the Lake County Code, including any development approval authorized by the Land Development Regulations, including but not limited to restrictions, notes, or other requirements contained within approved site plans or plats, developer agreements, ordinances or any resolution duly enacted by the board of county commissioners. The code enforcement special master shall also have jurisdiction to hear and decide an alleged violation or breach of any provision of a settlement agreement executed by the County and a party or participant resulting from a special master proceeding held under the Florida Land Use and Environmental Dispute Resolution Act (Section 70.51, Florida Statutes). The special master shall have all powers granted by statute, ordinance or by law. The standard which all cases shall be decided shall be by a preponderance of the evidence.

**Section 3.** <u>Amendment.</u> Section 14.00.13, Lake County Code, Appendix E, Land Development Regulations, to be entitled *Action by the Lake County Code Enforcement Special Master*, is hereby created to read as follows:

14.00.13 Action by the Lake County Code Enforcement Special Master. The Lake County Code Enforcement Special Master Shall have the authority to enforce the terms and conditions set forth in any development order issued pursuant to the Land Development Regulations, including but not limited to restrictions, notes, or other requirements contained within approved site plans or plats.

**Section 4.** Severability. If any section, sentence, clause, or phrase or word of this Ordinance is for any reason held or declared to be invalid, unconstitutional, inoperative or void by any court of competent jurisdiction, then said holding shall in no way affect the validity of the remaining portion of this Ordinance; and it shall be construed to have been the Commissioners' intent to pass this Ordinance without such unconstitutional, invalid or inoperative part therein; and the remainder of this Ordinance, after the exclusion of such part or parts shall be deemed and held to be valid, as if such parts had not been included herein; or if this Ordinance or any provisions thereof shall be held inapplicable to any person, groups of persons, property, kind of property, circumstances or set of circumstances, such holding shall not affect the applicability thereof to any other person, property or circumstances.

**Section 5.** <u>Inclusion in the Code.</u> It is the intent of the Board of County Commissioners that the provisions of this Ordinance shall become and be made a part of the Lake County Code and that the sections of this Ordinance may be renumbered or relettered and the word "ordinance" may be changed to "section," "article," or such other appropriate word or phrase in order to accomplish such intentions.
