


- > Tierra only pursues work that staff is available for.

### Understanding of the Project

- Tierra has spent a significant time reviewing the available documents and performing multiple site visits.
- General Information
  - Project based off the FDOT Traffic Operations Road Departure Safety Study (April 2018) includes:
    - Shoulder widening (5' paved 3' stabilized) at curves (8)
    - Pavement safety edge
    - · CR 452/CR 44 intersection improvements
    - Goose Prairie Road intersection left turn lane
    - Felkin Road intersection improvements realignment
  - LAP funded project



#### **Potential Issues**

- Project Cost
  - Engineer Estimate \$1.74 million (attachment sheet 1)
  - Tierra Estimate \$2.78 million (attachment sheet 2)
- Shoulder widening locations
  - Safety shoulders do not match FDOT Safety Report (attachment sheets 3-11)
- New pavement
  - Safety shoulders  $2\frac{1}{2}$ " SP 9.5, 1" FC 9.5 recommend SP 12.5 for structural coarse: ideal  $-1\frac{1}{2}$ " FC 12.5 only (plan sheet 5 (sheet 12)
- Goose Prairie Road
  - Milling and resurfacing 1" FC 9.5
  - Widening & shoulders 2 1/2" SP 9.5 1" FC 9.5
  - Recommend: various options depending on milling depth
- Existing pavement condition
  - Wheel path pavement failure (sheet 13)
  - Railroad crossing pavement markings (2018 detail) (sheet 14)
  - Stabilized shoulders mail delivery (sheet 15) drop-offs throughout
- o Contract Language
  - Normal weather days, plus hurricane days, plus holidays, plus special events





#### Comparable Projects

- Lake County, CR-450 Paved Shoulders from Marlon County Line to Lake Yale Road (LAP) (3.91 miles, Lanes 11' to 12' Lanes and 4' Safety Shoulders with Safety Edge, \$2,500,051.38);
- Citrus County, CR480 (Stagecoach Trail) from CR491 (Lecanto Hwy) to CR581 (Pleasant Grove) Widening and Resurfacing (LAP, Direct FHWA Oversite Project) (5.56 miles, 9' Lanes to 11' Lanes, \$1,090,138.00);
- Volusia County, Doyle Road Widening and Paved Shoulders (LAP) (2.40 miles, 10' Lanes to 12' Lanes and 3.5' Safety Shoulders, \$2,450,000.00);



#### Approach to the Project

- > Project constructed on time, within budget, safely and in strict accordance with the project documents;
- Influence the construction process so that the best possible results are obtained for Lake County;
- Provide Project Administration, Project Engineering, RCS services and Materials Inspection services required to insure full FHWA / FDOT project funding. Daily Inspection services can also be provided depending on Lake County requirements; Adapt to County's needs.
- > CEI service process to accommodate funding constraints as much as possible. Resident Engineer, Project Administrator, Project Administration Assistant and RCS all would be part-time or as-needed on the project. Our Project Inspectors would change to match the type of work being performed. All Project Inspectors are also CTQP certified so only have one person on-site to cover both inspection and testing duties. Extremely flexible process provides cost effective CEI service without jeopardizing to Lake County.
