## **UNDERSTANDING OF PROJECT**

This is a LAP Safety Improvement project that involves roadway safety improvements along CR 452 from CR 44 to the Lake/ Marion county line for approximately 8.928 miles. Improvements include:

- CR 452 & CR 44 Intersection: Traffic signal reconstruction from diagonal span to a box span, electrical service, traffic controller assembly, pre-emption system, vehicle detection system, internally
  - illuminated signs, luminaire bracket arms, minor roadway radius widening with Type F curb, minor drainage (18" pipe and 2-Ditch bottom inlets), add 5' paved shoulders
- Goose Prairie Road: Milling & widening, adding left turn lane (west bound) for approximately 1,500'
- Felkins Road: Realign/reconstruct with signing and pavement markings
- Add 5' paved shoulders (8' total shoulder) with safety edge at various locations throughout the project, both right and left roadways
- Construct numerous concrete and asphalt driveways throughout the project
- Thermoplastic pavement markings, both Standard and Profiled
- Per the County's Addendum #2, a PD&E Study is not associated with this project.



### SIMILAR PROJECT EXPERIENCE

E&R is extremely proud of the record of past professional accomplishments and experience in our Construction Engineering & Inspection (CEI) history. We have successfully completed more than 100 Florida Department of Transportation CEI projects ranging \$100M to \$500M in construction value and that include both Federal Aid and Non-Federal Aid construction dollars. We have extensive experience in managing LAP CEI projects and fully understand this process as we have managed several LAP projects in neighboring Sumter County and in all 17 counties/municipalities in Northeast and Northwest Florida for FDOT District 2.

**Neighboring Sumter County LAP project examples include:** C-478 Safety Improvements, Completed 11/2020; Sumter County Bridge Rehab SCOP Projects, Completed 11/2019; CR 470 Construction Safety Improvements, Completed 7/2019; and CR 575 Construction Safety Improvements, Completed 1/2019. These projects and others are detailed in <u>TAB C - Similar Projects Form.</u>

### APPROACH TO PROJECT

At Eisman & Russo (E&R), our construction approach is to start with the end in mind: A successful project, effectively administered, value-added, thoroughly documented per the County, FDOT and FHWA as required, well-coordinated to minimize traffic and community disruption, completed with quality on-time and on-budget in a safe manner. We do this by planning for success, anticipating issues to avoid problems, a bias toward action, clear and thorough communication, resolving issues at the lowest level, technical expertise applied in a partnering approach, and a demonstrated level of commitment and competence.

E&R's Project Approach includes providing Lake County the following:

**Team Continuity** – The collective expertise of E&R's inspection team, who are currently working together on other projects in Lake County will contribute to maintaining safe and successful project. Our established working relationships and local knowledge will assist with smooth and effective contract administration from Day 1.

Flexible Multi-disciplined Staffing – E&R maintains a staff of over 150 CEI personnel. Because of our ability to float personnel between multiple projects, we can consistently staff any assignment concurrently and at a moment's notice. Our team is a highly qualified "A" team that has provided excellent service on previous LAP projects and, therefore, is already familiar with policies and procedures.



Scheduling – Schedules will be evaluated for completeness and compliance with contract requirements. Focus on schedule deadlines will provide the County with information detailing staffing levels required to match the work effort. Contractor developed schedules will be analyzed as a baseline, matching time and cost deadlines with updated project activities.

Daily Construction Log – Our inspectors maintain detailed and accurate daily reports that are utilized to track the contractor's progress, schedule, and quantities and used as a check in interim progress/final payments. In support of this documentation, we maintain digital photo logs and GoPro video logs prior, during and at the end of the project.

**Project Management** – Proper management is the key to the success of any project. From pre-construction activities, through the construction process, all the way to project closeout, E&R is dedicated to success every step of the way. We fully understand what is expected of us.

Communication is Key – Through constant communication, many potential problems can be avoided. At weekly progress meetings, the following items are discussed: MOT, safety, progress of the contractor, planned activities, the schedule, Request for Information, Submittals, Issues, Contract Changes, Material Issues, as well as communication to the numerous communities throughout this project.

**EEO/DBE** – E&R is very familiar with the LAP process. We understand not only the documentation requirements but the field requirements as well. Ensuring documentation of the project bulletin board, Commercial Useful Functions (CUF's) are obtained from all drivers delivering construction material, and worker interviews are completed each month and timely submitted.

### **ISSUES & PROPOSED SOLUTIONS**

As on all of our projects, E&R's management approach is to take ownership of the project. For the CR 452 Safety Improvements Project, we have extensively researched the corridor and have thoroughly reviewed the plans, all other project documentation, and we have visited the project site for field inspection and review.

These plan and site reviews by E&R staff have afforded us the opportunity to present the following recommendations that we feel will expedite construction and avoid possible claim delays:

<u>Issue:</u> Plan Sheet T-4 Note 13. The cost for the use of "Traffic Control Officer" in the event of lane closures shall be incidental to the work and will not be paid separately. Since this is a reconstruct, there will be times where the signal will not be operational for short periods of time. We suggest, for the safety of the traveling public and the workers, this item be added. Without the pay item, the Contractor will most likely not use an officer.

Pay Item 0102-14 Traffic Control – FDOT Standard Specifications for Road and Bridge Construction 102-7 Traffic Control Officer. Provide uniformed law enforcement officers, including marked law enforcement vehicles, to assist in controlling and directing traffic in the work zone when the following type of work is necessary on projects: 1. When directing traffic overriding the signal in a signalized intersection.

**Solution:** Add Pay Item 0102-14 Traffic Control Officer to the plans prior to bid letting or if the note is used, direct the contractor that an officer must be used when signal is not operational.

Issue: Plan Sheet No. 205 – General Notes related to FDEP Contaminated Site, Note 2. If previously unknown contaminated soil is excavated during pipe installation process, contractor shall have a contingency plan for proper testing, disposal, and/or replacement. Solution: Add note that if encountered, all cost/ work associated with testing, disposal and/or replacement will be the contractor's responsibility. We suggest samples are taken prior to bid letting. If the contractor finds contaminated material, they will want to be paid for the testing, disposal, and replacement of the material along with the downtime labor and equipment which will require a Supplemental Agreement (FDOT LAP/ change order) along with getting funds approved by the County prior to the contractor doing this additional work. If it is determined ahead of time that the site is contaminated, the Engineer of Record can put notes and pay items in the plans to take necessary action.

<u>Issue:</u> Pay Item 110-4-10 Removal of Existing Concrete – Plan Sheet No. SQ-4. There are numerous concrete driveways throughout the project that do not show up in the Removal of Concrete pay item.



Basis of Estimates Chapter Index 000-199 110-4-A, Removal of Existing Concrete Pavement/ Removal of Existing Concrete. Consists of removing and disposing of existing concrete pavement, concrete sidewalks, slope pavement, ditch pavement and curb and gutter, where required, because of construction operations and when the work is not included in other operations (specifically excludes drainage structures).

Effective July 2017: Specification Sections 520, 522, and 524 were updated to exclude removal of concrete curb elements, sidewalk, and barrier wall under the respective 520, 522, and 524 pay items. Removal of these items is now included in the SY item for Removal of Concrete, per the Section 110 Specification. Each type of concrete to be removed (sidewalk, curb, pavement, retaining wall, barrier wall, etc.) will need to be identified on the summary box.

**Solution:** Concrete driveways are 6" Concrete Sidewalk. Quantify the existing concrete driveways and add to Pay Item 110-4-10 Removal of Existing Concrete – Plan Sheet No. SQ-4 prior to bid letting.

<u>Issue:</u> Pay Item 110-4-10 Removal of Existing Concrete – Plan Sheet No. SQ-4. Numerous concrete driveways have cracks beyond the areas identified to be reconstructed. The areas may pose an issue when removing existing concrete. In our experience, areas that are cracked may deteriorate further (loosen more) during the other operations. <u>Solution:</u> Quantify these potential areas. If these areas are not identified prior to the bid letting, overruns are likely in this pay item to replace these areas. Such will require a Supplemental Agreement (FDOT LAP/ change order) along with getting funds approved by the County prior to the contractor doing this additional work.



**Issue:** Pay Item 570-1-2 Performance Turf, Sod. When boxing out during shoulder operations for the new shoulders, contractors historically like to roll the excess material all the way down the slope to the ditch bottom instead of removing the excess material. **Solution:** The E&R inspection team will keep a close eye on the slope's percentages shown on the cross sections and keep the contractor from causing unnecessary overruns to this item.

Issue: There are numerous communities throughout the project including Sandpiper, Quail Ridge Estates, Lake Yale Estates, Wedge Wood, Windy Ridge, Raintree Harbor, Lake Yale Landing, Yale Retreat Mobile Home Village and Southern Palms that will need to be notified of the construction activities. Solution: E&R is committed to communicating with the various communities to keep them informed while providing the E&R Point-of-Contact to all stakeholders. This will generate confidence and bond with the associations in the area, help minimize complaints and results in being a good neighbor. We have a solid understanding of who our customers are and the importance of their satisfaction and safety while traveling through the construction area.

<u>Issue:</u> Keeping the City of Eustis in the loop as part of this project is within the Eustis city limits. <u>Solution:</u> We will provide them the E&R Point-of-Contact and keep them notified as the project progresses.

Issue: Lane closure safety. Goose Prairie Road has a big hill down to it (westbound). Solution: The CEI team and the contractor must give special attention to during flagging operations as speed and sight distance need to be monitored closely so there are no rear end collisions when traffic is stopped. Issue: Felkins Road realignment. This intersection is in a curve. Solution: The CEI team and the contractor must station flagmen so they can be seen easily by vehicles traveling through this area during the realignment/reconstruction operations. We recommend at both Goose Prairie Road and Felkins Road, due to sight distance concerns, that a PCM board be added to warn motorist. Add Pay Item 102-99 to the contract.



Issue: The new box span traffic signal work at the intersection of CR 452 and CR 44 will be closely coordinated with Centurylink (buried telephone), City of Eustis (water/wastewater), Florida Gas, TECO Energy (power), Duke Energy (distribution/transmission) and Comcast (cable). All utilities are in close proximity to the various operations to take place at this location. If utilities are not where the plans indicate, there will be conflicts. **Solution:** It is crucial that the contractor stake the new traffic signal pole locations (Pole 1, 2, 3 & 4) and call for locates at the start of the project. In being proactive early on the project, conflicts can be addressed in a timely manner and minimize cost/ time delays. E&R will hold a Pre-drill (signal pole foundations) meeting with



utility companies, apart from the Pre-con, to discuss the protective measures required to work within close proximity to power lines. E&R has extensive and good experience with utility companies in the area.

<u>Issue:</u> The overhead power is in close proximity to the removal of existing traffic signal poles and installation of four new signal poles and will require a crane working close to power lines. <u>Solution:</u> The E&R team is experienced in construction close to overhead power; coordination early in the project is important in order to keep to schedule and avoid outages.

**Issue:** Pay Items 102-60 Work Zone Sign, 102-74 Channelizing Devices are calculated on Plan Sheet SQ-1 as 310 days. Proposed schedule is 370 contract days. **Solution:** Correct quantities to reflect 370 days to prevent overruns to pay items.

<u>Issue:</u> Pay Item 0570-1-2 Performance Turf (Sod) Plan Sheet SQ-9 does not reflect lengths or widths in designated columns on the matrix. <u>Solution:</u> Identify the length and widths for each location to prevent unnecessary overruns.

### **SCHEDULE**

The County's proposed schedule is below. Eisman & Russo will begin upon written notification to proceed, ideally three weeks before the contractor's notice to proceed to prepare and hold the Pre-con meeting, video and photograph existing conditions, communicate with the area communities/stakeholders, review the contractor's schedule and sequencing of work. Following final acceptance, E&R will close the project out with the County, contractor, EEO, etc. We are committed to meeting the County's time requirements.

### 3-STEP PLAN FOR SUCCESS

The E&R team will utilize a 3-step plan, as outlined below, to ensure the quality delivery of the CR 452 Safety Improvements Project to Lake County.

**STEP 1:** Provide a quarterly assessment of our project and staff. This assessment will be performed by Senior Project Engineer Elie Assi, PE and will include a discussion with Lake County and an in-depth review with the CEI team. Elie Assi and the Resident Compliance Specialist, Angela Spahn, will utilize a tailored, project-specific version of our project QA checklist. This checklist includes procedural queries based on contract documents, specifications, the FHWA LAP Checklist (short form, long form), CPAM, and QA/QC Guidelists and serves as a checklist to ensure that the CEI team has the necessary tools and documents as well as a thorough understanding of how they are applied. This serves as a baseline for project management checklists and will be supplemented by various FDOT guidelines and manuals will need to be modified and incorporated within Lake County's own specifications and requirements to have a successful partnership. Monthly and Final pay applications, specifications, operating procedures will be applied during the project.

**Step 2:** Provide additional support and training to the CEI LAP team members. This will be accomplished by Project Administrator/ CSS Eddie Ferris. The purpose is to share changes to Department LAP policies and procedures with our team, reinforce safety concepts, partnering concepts and provide mentoring and support. The intent is to keep everyone up to speed with any changes being implemented to the LAP program in a consistent fashion.

**STEP 3:** Keeping the accounting, timesheet, budgets, OT logs, and contracts current with an understanding of remaining funds is one of the many tasks that the E&R team will perform. We will develop Excel spreadsheets for this project that compares actual hours to estimated hours. Prior to submitting an invoice, Ellie Assi, PE together with Accounting Manager Angila Maxwell will perform a review to ensure correct submittals the first time. Performing QA of the budget is the first and last step of our process, to ensure that adequate funds are available for the upcoming month, for ensuring our documentation is complete for the previous month, prior to submitting the invoice.



### **QUALITY ASSURANCE / QUALITY CONTROL**

E&R understands Lake County's quality goals and is committed to make certain those goals are met. At E&R, quality is part of our culture and our commitment to quality is an ongoing process, evaluated on a regular basis, to allow us to achieve the highest standards. The E&R team will ensure the contractor builds all construction items according to the contract documents and in accordance with our project specific Construction Quality Control Plan that includes Construction Engineering & Inspection (CEI), Resident Compliance Specialist (RCS), and material testing requirements.

The E&R QA/QC team has significant construction experience, understands Federal Highway Administration (FHWA) LAP requirements, and will provide a consistent product throughout construction of the project. At the start of the project, we will have in place an internal project specific Quality Assurance Program (QAP) that will provide the overall structure, policies, and procedures necessary for the successful execution of the project. We are well experienced in LAP projects; we already have a well-developed and proven tool in a LAPIT QA Review Checklist specific to LAP projects, as exampled below.

The QA/QC team will be led by Jim Boughanem, PE who will conduct intermittent project reviews for the CR 452 Safety Improvements Project to ascertain contract compliance. The quality assessment review will include, at a minimum, the following: Office and Equipment, Safety Contractor's Schedule, Documents and Manuals, Contract Administration and Recordkeeping, Daily/Weekly/Monthly Reports, Weekly Progress Meetings, Testing and Inspection Procedures, Document Control System, Contractor's Equipment, Environmental Compliance Response to Plans & Specifications Questions, Construction Inspection Staffing & Training/ CTQP, Management of Contractual Disputes, Plans/Shop Drawings, Materials (Asphalt, Earthwork, Concrete), Contract Compliance (EEO + FHWA LAPIT Checklist), Final Estimates and Schedule of Values.

Once the quality review document is finalized, QA/QC lead, Jim Boughanem, PE will submit a report to LAKE County's Project Manager that will outline any substandard performance area requiring corrective action. The same report will be submitted to SPE Elie Assi, who will see that the recommended corrective action is performed within 10 working days. Once corrective action is achieved, the QC Team will submit an updated report documenting the corrective action and submit it to the Lake County Construction Project Manager with file copies maintained in our quality assurance records.
