It is important that you understand the importance of following the Government in the Sunshine law (Section 286.011, Florida Statutes), the Code of Ethics (Chapter 112, Part III, Florida Statutes), Lake County's Employment Policies Manual, and the Lake County Purchasing Procedure Manual. Once the solicitation and evaluation process has begun, it is essential that any contact with the vendors and potential vendors be done only through the Office of Procurement Services. In addition, you are not to communicate any information about the solicitation or evaluation process, except during SC meetings, with any vendor, potential vendor, or other SC member until a final award decision is reached by the County. Vendors have been directed in the solicitation documents to make all contact directly with the Office of Procurement Services during the entire process. Given the importance of conducting the evaluation process in a fair and transparent manner, you are asked to confirm the following statement:

I have read and understand the above and agree to be bound by all applicable laws, policies, and procedures. My recommendations will be based upon my critical analysis of the vendor's response and the appropriate award criteria from the solicitation in accordance with the Lake County Purchasing Procedure Manual. To the best of my knowledge, there is no conflict of interest or other factor that would compromise my impartiality. Neither I, nor any of my relatives have a personal interest in any of the vendors cited above. I agree that if I currently have, or later discover a conflict of interest, I will declare the circumstances immediately to the Office of Procurement Services Director and remove myself from the committee.
