

Trail crossed through forested rural areas, in front of businesses, residences, a boat launch, and crossed US 98 at multiple locations. Landscape design focused on providing safety for the users by utilizing selective clearing to not only remove nuisance and exotic species from the site but to improve visibility and therefore increase safety for the users. Safety was also considered at trail crossings as plantings were used to alert users of potential pedestrian/vehicular conflicts. Plantings were designed with seasonal blooms and fall color amongst evergreen plant materials with varying textures to provide interest and year-round appeal. Trails were placed appropriately with canopy trees to provide for human comforts while maintaining vies of important site features, such as the 50-acre lake. Plantings were also used to screen views and provide privacy for residents.

SCOPE of Project (list tasks, outlines or descriptions of items): Kimley-Horn led this PD&E Study that encompassed more than 30 miles of paved trails within the Merritt Island National Wildlife Refuge (MINWR) and Canaveral National Seashore (CANA) in Brevard and Volusia Counties, all within federal lands. After the completion of the PD&E study, design began on an 11-mile segment. This trail is part of the SUN Trail network and a segment of the Coast-to-Coast Trail. The project included extensive coordination with the U.S. Fish and Wildlife Service (USFWS), National Park Service (NPS), and National Aeronautics and Space Administration (NASA). Monthly coordination meetings were held with the federal agency partners to discuss progress, share information, and ensure that the project was completed on schedule. The PD&E study involved the preparation of an Environmental Assessment for USFWS and NPS signature in addition to a State Environmental Impact Report (SEIR) for District Five signature. For the 11-mile design segment, components of the design included: roadway design, milling and resurfacing, intersection design, ADA accommodations, pavement design (concrete pavement for railroad crossing), structural design (box culvert), drainage design, environmental services, signing and pavement markings, Rapid Rectangular Flashing Beacon (RRFBs) at roadway crossings, utility coordination, and environmental permitting.
