INSTRUCTIONS FOR USE OF WASTE TIRE COLLECTOR REGISTRATION DECALS

1. The enclosed decal(s) shall be displayed on the outside of the driver's front door of the vehicle(s) assigned to them.
2. Records shall be maintained for three years and shall be available for inspection by Department personnel during normal business hours. The records shall be summarized quarterly and shall contain the following:
 - a. Total quantity of waste tires collected.
 - b. Where and from whom waste tires were collected and the quantity in tons collected from each location.
 - c. Where the waste tires were deposited and the quantity, in tons, deposited at each location.
 - d. Receipts or other written materials documenting the above.
3. A Waste Tire Collector Annual Report, DEP Form 62-701.900(22) shall be submitted by March 1 of each year, when you renew.
4. A Registration Renewal Application, DEP Form 62-701.900(18) shall be submitted by March 1 of each year to renew this registration.
5. A Waste Tire Collector shall leave waste tires and processed tires for storage and disposal only at a permitted waste tire processing facility, a permitted or exempt waste tire collection center, a permitted solid waste management facility, or at another site permitted by the Department to receive waste tires.
6. Any person who fails to comply with these conditions is subject to having their Waste Tire Collector Registration denied, suspended, or revoked, as well as other penalties provided by law.
7. When a Waste Tire Collector Registration number expires or is surrendered, suspended, or revoked, the registration decals shall be removed from all vehicles immediately.
