The County is seeking quotes for the purchase of two (2) agricultural 2 WD broom tractors with enclosed cabs for the Lake County Department of Public Works - Road Operations Division.

The agricultural 2 WD broom tractors shall meet all applicable requirements of the American National Standard Institute (ANSI) Safety Standard as required by the Occupational Safety and Health Administration (OSHA) at the time of manufacture.

Awarded contractor shall provide on-site operator and mechanic training upon delivery of tractors.

The County will not accept prototype equipment. The equipment shall be built for the U.S. Market and sold or leased by a factory-authorized dealer.

The equipment proposed on this request shall be the manufacturer's standard equipment with no alterations. The County will not lease or purchase altered equipment or custom designed equipment unless expressly provided for in this proposal document.

The contractor shall furnish all tools and equipment (if necessary) for normal field adjustment of the awarded equipment. Prices for the foregoing shall be included in the proposal price.
