

Date	Time (approx)	Who	Summary
10/26/10	betw 09:30 & 12:30	Machine	Ray Sullivan left two messages on the answering machine, saying that the roads are in bad shape. Said that his neighbor's wife has a back problem and needs to be transported by ambulance. Did not leave a phone number.
10/27/10	11:00	Wall, Treeva	Mr. Sullivan called with his phone number. Also gave me 386-456-7007, Irvin Bair, another citizen on the road. Mr. Sullivan told me repeatedly about how bad the roads were and talked about his concern for his neighbor's wife. Several times, I told him that we had not been able to call him back initially because he didn't leave his phone number on the answering machine; but that I would make sure the Supervisor got his message.
10/27/10	11:15	Hicks, Chris	Called and spoke with Mr. Bair. Explained that we can not work on the roads due to lack of Publicly-dedicated Right-of-Way. Attempted to call Mr. Sullivan - no answer.
10/27/10	12:10	Hanson, Jodine	Ray Sullivan (589-5754) called for Commissioner Stewart to relay that Mr. Hicks, Public Works, has denied fixing Jewel and Leslie, both non-county maintained roads. He conveyed that Mr. Bair (386-456-7007) had spoken to Mr. Hicks that morning. Mr. Bair's wife Linda is in the hospital with 5 broken discs and a deteriorated spine and will need to travel down these roads when she comes home. Mr. Bair and Mr. Sullivan are concerned about what these roads will do to her. They'd like the roads graded, watered and clay put down. As Commissioner Stewart was not expected in the office I referred him to Sandy Minkoff.
10/27/10	12:20	Booth, Niki	On Wednesday, 10/27 at approximately 12:20, Jodi transferred Mr. Sullivan to me so he could speak with Sandy. He reiterated to me what he told Jodi (about the roads and Mr. Bair's wife, etc.). He wanted the roads fixed and threatened that "someone" would be liable if Mr. Bair's wife was further injured. I explained to him that these roads are non-county maintained roads, which he did not want to accept. After I hung up with Mr. Sullivan, I called Karen Burt to explain the situation to her.
10/27/10	12:50	Hanson, Jodine	Ray Sullivan called for Commissioner Stewart wanting to talk to her about Jewel and Leslie. I told him again that she was not in and that I understood that Randy Dean, Public Works, was going to go out and take a look at the roads but that I didn't know if it would be today, and that I understood the roads are in the middle of private property and that you have to travel private easements to get to them and that Randy Dean wasn't sure how close he could get to them. Mr. Sullivan wants a phone call back today as to the status and indicated that if he has to, he will set up a meeting with the news media. ----As a side note, I shared the info from the 2nd phone call with Niki for Sandy. At approximately 2pm, Niki shared with me that per Karen Burt, the County has no ROW to even go look at these roads. Niki was leaving a message for Sandy to call Mr. Sullivan back. Niki mentioned to me later in the afternoon that Sandy would be calling Mr. Sullivan sometime Thursday morning.
10/27/10	13:30	Wall, Treeva	Mr. Sullivan called and wanted to know when we were going to check the roads. I told him that Chris had tried to call him, but there was no answer. I told him that Chris had spoken to Mr. Bair. He said he would call Mr. Bair. He told me several more times about the condition of the roads.
10/28/10	13:00	Wall, Treeva	Mr. Sullivan called, saying that he knew Randy was directed to check the roads for passability. Wants Randy to call him back. He told me, again, at length, about the condition of the roads.

10/28/10	13:15	Merrill, Jeanne	Mr. Sullivan was irritated and asked for Comm. Stewart or any Commissioner. I told him that no one was here right now. He said that someone needed to call Randy Dean about the roads getting fixed so that Mr. Bair could bring his wife home from the hospital this weekend. He said that if she injures herself from the roads, someone is going to be held accountable and that he would call the news stations. He said he pays taxes and doesn't understand why the roads aren't paved. I was going to call Randy Dean but then Jodi explained to me what was going on and that Sandy Minkoff was going to contact him, so I told Niki what had just transpired on my call.
10/28/10	13:40	Wall, Treeva	Mr. Sullivan called, wanting to know if I had given Randy his message. I told him that I had. He wanted to know if Randy was going to check the roads. I told him that I didn't know, and that all I could tell him was that I had given Randy the message. He became more aggressive and continued to press for more information. After I repeatedly told him that I had given Randy his message, he said he'd "just have to take care of it."
10/28/10	14:15	Dean, Randy	Called Mr. Sullivan and told him again that we have no Right-of-Way and can not do work on the roads. After a lengthy discussion, he said that if his neighbor dies, he will kill the Commissioners and anyone else that stood in the way of the road being fixed.
10/28/10	14:20	Merrill, Jeanne	Mr. Sullivan was mad. He said that someone from the County had just contacted him to say that the roads were non-county maintained. I told him that I thought it was Sandy Minkoff. He was very loud and very upset and he kept repeating that the roads needed to be fixed. He said that all it would take was 1 phone call from a commissioner, that that was how things worked. He threatened again that if Mr. Bair's wife was injured further, someone would be held liable. He said he would call Fox news.
10/28/10	14:20	Dean, Randy	Called Dennis Warren to report the threat.
10/28/10	14:25	Warren, Dennis	After consulting with Jim Stivender, instructed Randy Dean to make a report to the Sheriff's Office.
10/28/10	14:45	Dean, Randy	Deputy Joe Brocato (#1528) responded to the barn and took the report. Report # 1017-8844.
