RE: Roads within Valencia Terrace

Dear Mr. Mullis:

Thank you for your letter dated December 2, 2013 regarding the roads within Valencia Terrace subdivision. To give you some background information, every road in the County maintenance system is inventoried and annually inspected in April for pavement condition. The pavement inspection process of the road inventory is based upon the PASER (Pavement Surface Evaluation & Rating) System developed by the University of Wisconsin-Madison Transportation Information Center. This system is a visual inspection and evaluation process to assess the surface condition of the road and assign to it a 1-10 rating category. A "1" rating would be a failed road in need of total reconstruction and a "10" rating would be a newly constructed road in excellent condition. Each individual rating takes into account factors such as surface defects, surface deformation, cracks, and patches or potholes. The information gathered during the annual pavement inspection process is, in turn, used to plan road surface improvements such as road resurfacing and pavement preservation techniques to extend the life of the roadway. A road that has a pavement rating of "4" is considered for resurfacing with a one-inch asphalt overlay. Ranking of these roads prioritizes them first by lowest to highest pavement condition and then highest to lowest traffic count. After the priority of raking is established, budgeted funds are allocated until they are exhausted; thus establishing the annual resurfacing list. Roads not resurfaced due to funding constraints are re-inspected and re-evaluated the following year.

The roads within Valencia Terrace (Black Bass Circle, Sailfish Avenue, Trout Avenue, Starfish Avenue, Bream Circle, and Kingfish Street) were evaluated in April 2013 and are currently rated a "5". I have been on these roads lately and they are most definitely not appealing to the eye. These roads are showing signs of aging with severe raveling (loss of fine and coarse aggregate) and severe flushing and polishing; however, they are still considered to be in good structural condition as "5" rated roads.

There are over 300 miles of County maintained roads that are currently rated a "5" and to resurface these roads using today's cost would be in excess of \$22 million. With an annual resurfacing budget of approximately \$2 million, it is prudent that we monitor all "5" rated roads as they reach the "4" threshold for resurfacing consideration and plan accordingly for necessary improvements. Although I do not have a scheduled date as to when the roads within Valencia Terrace subdivision will be resurfaced, please know that we will continue to closely monitor them.

I have lived in the same home for 36 years this month and to my knowledge the streets have never been resurfaced. ( Correct me if I am mistaken.)



Thank you in advance for your kind consideration in this matter.



