I see a note fro lori, in the info you gave me, reminding you to follow up with Mr. Saieva once we get back with you on our RW research. We should be finishing our review of the RW deed (obtained through the Planning Dept) to make sure title and legal are good, so we can then get it accepted by the BCC. **However, we need a clarification of exactly where the end of County maintenance is located.** The County maintained book indicates that the length of county maintenance is paved for 1935 feet. This still leaves about 660 ft., lying South of the RW deed that we are reviewing, that is not paved or County maintained, with only 33 feet half RW lying West of the Section line. It should be noted that this subject RW deed we are reviewing is <u>also</u> located all West of the Section line, so it would seem that we would need to get the additional 17 ft. from the property owner lying South of Mr. West of the Section line. It may take a survey to determine where the edge of pavement is located to determine where our maintained rights are located, so that we can determine what additional RW is needed to connect to County maintained paved road on the South.

If possible, we need someone in Road Ops to let us know exactly where the County maintenance ends, because on portions of this roadway, we only have maintenance rights on what we maintain (between the edges of pavement). I would be happy to meet with you and Mr. Saieva to explain the RW aspects of this possible project, and it would be a whole lot easier to explain, while looking at our maps and research information.

Since we are spending a good amount of time on this inquiry, it would be nice if an SA request form/file was started, so we could document our findings. I think that is why we started using the SA forms for all these request, as many of the SA requests end up with issues to be resolved, just like this – and keep coming back. If you submitted the form, with the limits of the request shown on a map, then a file would be started, and all this research would be documented (in your office and in mine). If there is an issue with RW, where we do not have the continuous min. 50 ft., it would not be forwarded to the engineers, but returned to you with an explanation (and all would be documented if the inquiry is received again). Thanks for your help. Patti
