

To Whom It May Concern:



Two or three years ago a couple of large, earth moving vehicles belonging to Lake County dug a ditch in the middle of the easement directly in the front of my property. I called and spoke to a man (Ron, Rich perhaps) who informed me that everyone in Lake County has this unsightly ditch in their front lawn and that the purpose of my ugly ditch was to accommodate my new neighbor who was having a problem with water flowing onto his property. I watched over the years as the street in front of my house became an unsafe traffic disaster. He needs to be told that the county is not responsible for his rain problems and he simply needs to move his driveway further into the middle of his property where there appears to be less runoff. A better solution might be a concrete apron like the one I have on my property.

In any case, Lake County needs to stop trashing the front of my property to appease my neighbor. It is unfair and disrespectful to me, unsafe for people traveling on North County road 44A and a waste of taxpayer money.

I want my dirt back (it is where you left it in a weed covered pile in David's front yard) so that the easement in front of my house can be restored to a safe side of road and I will no longer have the extra work and expense of cleaning up the road as it breaks apart and slips into the area that I mow and maintain. Please price mower blades on a large mower to understand a part of my frustration, not to mention that I am an older woman with a full time job at Florida Hospital who simply does not have any more time to clean up after the counties' poorly conceived plan.
