Chief Molenda,

Attached is map of Bartram Road in Astor. As indicated in Lori's email below, there has been significant flooding to Bartram Road. I've asked Fire Rescue and the Sheriff's Office to go out daily and evaluate. As we discussed, this road may pose a problem for all public safety vehicles to travel. In the attached picture, the yellow lines indicate the parts of Bartram Road that have been significantly flooded.

In terms of FEMA assistance for a non-County maintained road and its improvement, there is no immediate remedy available. The process to determine if any type of funding is available for private roads will take time and require the applicant to go through a state/federal grant process.

Hi Tommy, please see email below. I believe the correct name of the road in question is Bartram Road, which is located directly adjacent to the St. Johns River. I was hoping you might have information to share in regards to FEMA and flooding on this non-County maintained road.

From a road maintenance perspective, there is nowhere to divert the water in this area. As you know, there are several roads under water in Astor, and I'm unaware of any FEMA funds to repair roads – even those that are County maintained.
