Please see below the last email that was sent regarding the removal of the 50" oak tree located near 1250 Gray Court. The majority of this tree is located in the right of way, but a portion of the tree may encroach on both 1250 Gray Court and 1280 Gray Court. Mr. Jerry Evans (1280 Gray Court) notified our office and requested that the tree not be removed. He would not sign a right of entry form to allow Chad/Total Land & Tree to enter their property to remove the tree. Mr. and Mrs. Blossey (1250 Gray Court) are seasonal residents and were not home or available to sign a right of entry form at the time the work was being completed.

This tree was later removed from the work order by Jim, (I believe at the bequest of Mr. Evans). Mrs. Blossey is upset that the tree was not removed and wanted to know if there is anything that can be done to get this removal completed. This tree was identified by the arborist as one that should be removed but was taken off the list by Jim.

How should we proceed?
