3. Turn right onto Wolf Branch Rd.

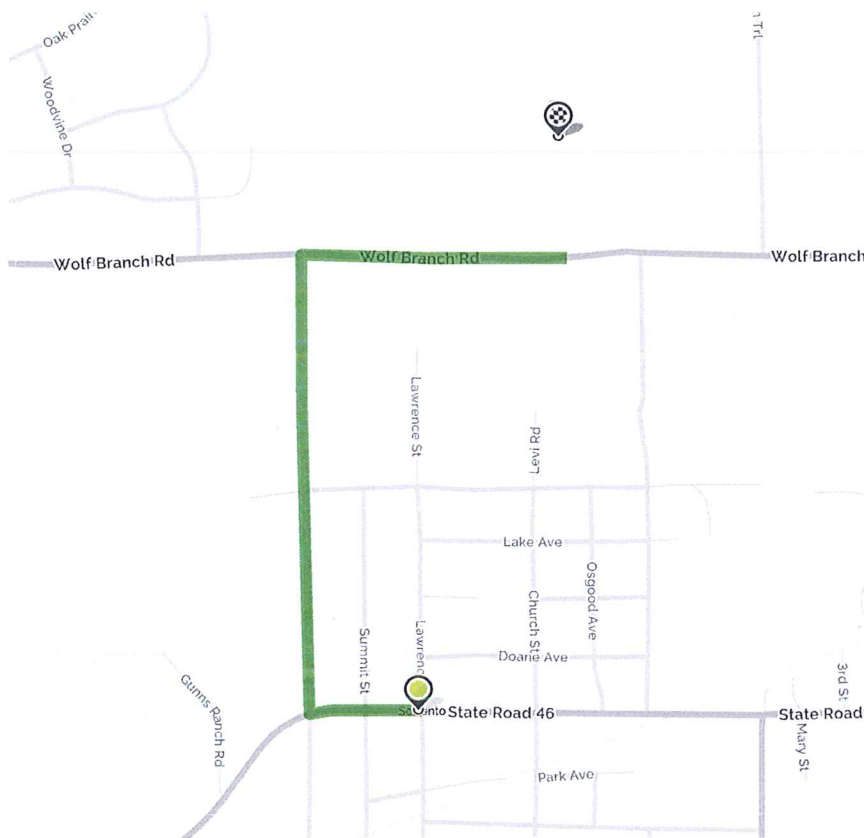
