4. Turn right onto Yale Retreat Rd.
Yale Retreat Rd is 0.1 miles past Paradise Dr.

If you reach N Country Rd you've gone about 0.2 miles too far.

5. Yale Retreat Rd becomes Old Chisholm Trl.
Then 0.28 miles 3.08 total miles

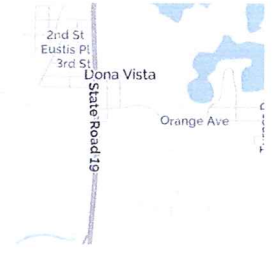
6. Turn left to stay on Old Chisholm Trl.
