Thank you for the update. Lana is not going to be home tomorrow and we do not want any work starting without her being home. Considering the fact that our neighbor does not want his property disturbed, we have concerns that even after the work is done on our property, we will still have runoff from the neighbor's yard which is a new post-roadside grading issue (it enters from the side not up by the road). If it does not stop the majority of the water from racing down to the lake, a swale (which we presently envision will not look as good as the terrain does presently), may not be the route we want to take.

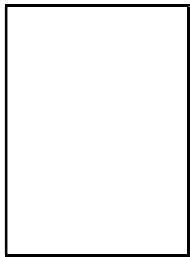
Please push us farther out on the schedule while we figure things out.
