Good morning, Commissioner Blake and Andrea,

North Road is a non-County maintained road. Our records indicate that we repaired a washout within the right-of-way in January 2017. We do not sell millings to property owners as our stockpile is limited, and we use them on our County maintained roads as well as on non-County maintained roads like this one.

Mr. Hanley drives a school bus and parks the bus at his residence. We have spoken to him and the principal of the Altoona Elementary School in the past and advised that local contractors may have millings for their use. It was our understanding that they were going to contact a contractor about the milling material and performing additional work beyond the right-of-way.
