AND LAKE COUNTY, a political Subdivision of the State of Florida, having

WITNESSETH: That the first party in consideration of the sum of One Dollar (\$1.00) and other valuable considerations paid, the receipt of which is hereby acknowledged, hereby grant, bargain, and sell unto the second party, its successors and assigns forever, a PERMANENT EASEMENT to the said property herein described in Lake County, Florida, to wit:

THE WEST 30 FEET OF THE FOLLOWING DESCRIBED PROPERTY LYING NORTH OF THE RIGHT-OF-WAY OF STATE ROAD 452:

Commence on the west line of Government Lot 3, Section 35, Township 19 South, Range 26 East, 300 feet north of the centerline of State Road 452; thence run southeasterly parallel to said State Road 452 134.00 feet; thence run south to Lake Dora; thence run westerly along lake to a point south of the Point of Beginning; thence run north to the Point of Beginning.

This Easement is for drainage purposes only.

Lake County will reasonably restore shrubbery that will temporarily have to be moved during pipe and inlet installation.

Lake County will allow future connections to drainage system, provided that said connection is approved by the County Engineer and further provided that it is made at no cost to Lake County.

Property disturbed by excavation will be restored to a level condition.
