I agree, we should have at least the minimum 50 ft. public RW (and that often is tight). As you know our standard for rural roads with swales is 66 ft. But at least the 50 ft. will get us started. Attached is a map showing where we have deeded RW, and where we have maintained RW. On maintained RW, we would most likely only claim the travel way.

Also, we recently obtained a couple of Drainage Easements along this roadway for Jeff, which are not shown on the layer yet (they are attached FYI), at that time we did a survey for about the first 660 ft. (road maintenance book says the length we maintain is 1690 ft.). That tells us we may have other drainage issues out there to deal with if we pave the road. The survey shows the existing roadway to be located in the Northerly half of the deeded RW, so we would probably need RW from 6 people on the North side. Patti
