

RESOLUTION NO. 17-19

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF EUSTIS, FLORIDA, ACCEPTING OWNERSHIP AND MAINTENANCE RESPONSIBILITY OF KURT STREET/W. LAKEVIEW AVENUE PER THE INTERLOCAL MULTI-PHASE INFRASTRUCTURE AGREEMENT DATED AUGUST 11, 2015 BETWEEN THE CITY OF EUSTIS AND LAKE COUNTY, FLORIDA.

WHEREAS, the portion of Kurt Street/W. Lakeview Avenue between U.S. Hwy 441 and Bay Street is owned by both Lake County and the City of Eustis; and

WHEREAS, Lake County and the City of Eustis agreed to an interlocal agreement for a 50/50 funding of the Kurt Street/W. Lakeview Avenue Improvements project; and

WHEREAS, upon completion of the roadway improvements, the City of Eustis agreed to retain sole ownership and maintenance responsibilities of Kurt Street/W. Lakeview Avenue; and

WHEREAS, the City of Eustis consents with Lake County that all agreed upon roadway repairs are complete.


NOW, THEREFORE, BE IT RESOLVED by the City Commission of the City of Eustis, Lake County, Florida, as follows:

- (1) That the City Commission hereby agrees the infrastructure improvements to Kurt Street and W. Lakeview Avenue as defined in the attached agreement have been completed; and
- (2) That the City Commission hereby authorizes the City Manager to accept ownership and acquire all future maintenance responsibility on this portion of Kurt Street/W. Lakeview Avenue in its entirety.
