INTERLOCAL AGREEMENT BETWEEN LAKE COUNTY, FLORIDA AND THE CITY OF GROVELAND, FLORIDA TO TRANSFER JURISDICTION OF SAMPEY ROAD (CR 1520)

THIS INTERLOCAL AGREEMENT is by and between Lake County, Florida, a political subdivision of the State of Florida, hereinafter the "County," and the City of Groveland, Florida, a municipal corporation organized under the laws of the State of Florida, hereinafter the "City," to transfer jurisdiction of Sampey Road (CR 1520) located in Groveland.

WHEREAS, Section 163.01, Florida Statutes, provides that local governments may enter into interlocal agreements to make the most efficient use of their powers by enabling them to cooperate with other localities on a basis of mutual advantage; and

WHEREAS, Section 335.0415, Florida Statutes, provides that public roads may be transferred between jurisdictions by mutual agreement of the affected governmental entities; and

WHEREAS, Sampey Road (CR 1520) runs from State Road 50 to the end of County maintenance at East Phelps Street; and

WHEREAS, it is in both the County and City's best interest to transfer the jurisdiction, ownership interests, operation and maintenance responsibilities associated with Sampey Road from the County to the City; and

WHEREAS, the County intends to make improvements to the surface of a portion of Sampey Road and by doing so facilitate the transfer of Sampey Road in the City's jurisdiction.

NOW, THEREFORE, IN CONSIDERATION of the mutual terms, understandings, conditions, premises, and covenants hereinafter set forth, and intending to be legally bound, the parties hereby agree as follows:

- 1. Recitals. The foregoing recitals are true and correct and incorporated herein by reference.
 - 2. County Obligations.
- A. In accordance with Section 335.01415, Florida Statutes, the County agrees to transfer to the City any and all jurisdiction, ownership interests, operation and maintenance responsibilities that the County may have in Sampey Road (CR 1520), extending from East Broad Street (SR 50) to the end of County maintenance at East Phelps Street, as specifically

identified in Exhibit A, attached hereto and incorporated herein by reference, effective on the date the last party hereto executes this Agreement ("Effective Date").

- B. Within six (6) months of the Effective Date of this Agreement, the County agrees to resurface, at no cost to the City, 851 linear feet (LF) of Sampey Road (CR 1520), which lies between East Broad Street (SR 50) and Beverly Drive. The County shall utilize its existing on call-contract for road resurfacing and striping and shall be solely responsible for the work. The County agrees to provide the City with notice at least two (2) weeks prior to start of resurfacing work and in exchange, no right of entry, permit or other prior approval will be required by the City prior to start of the resurfacing work of this subject 851 LF.
- 3. City Obligations. The City shall accept any and all of County's ownership interests, operation and maintenance responsibilities of Sampey Road (CR 1520) as identified in Exhibit A, upon the effective date of this Agreement in accordance with the provisions of Section 335.0415, Florida Statutes.
- 4. Modifications. Unless otherwise specified herein, no modification, amendment, or alteration of the terms or conditions contained herein shall be effective unless contained in a written document executed by the parties hereto, with the same formality and of equal dignity herewith.

5. Notices.

A. All notices, demands, or other writings required to be given or made or sent in this Agreement, or which may be given or made or sent, by either party to the other, shall be deemed to have been fully given or made or sent when in writing and addressed as follows:

B. All notices required, or which may be given hereunder, shall be considered properly given if (1) personally delivered, (2) sent by certified United States mail, return receipt requested, or (3) sent by Federal Express or other equivalent overnight letter delivery company.

The effective date of such notices shall be the date personally delivered, or if sent C. by certified mail, the date the notice was signed for, or if sent by overnight letter delivery company, the date the notice was delivered by the overnight letter delivery company.

Parties may designate other parties or addresses to which notice shall be sent by notifying, in writing, to the other party in a manner designated for the filing of notice hereunder.

Entire Agreement. This document embodies the entire agreement between the parties. It may not be modified or terminated except as provided herein.

7. Severability. If any provision of this Agreement is found by a court of competent jurisdiction to be invalid, it shall be considered deleted here from, and shall not invalidate the remaining provisions.

Effective Date. This Agreement shall become effective upon the date the last 8. party hereto executes it.

IN WITNESS WHEREOF, the parties hereto have made and executed this Interlocal Agreement on the respective dates under each signature: Lake County, through its Board of County Commissioners, signing by and through its Chairman, and by the City of Groveland, Florida, through its City Council, signing by and through its Mayor.
