Our policy is that we try to make Non-Maintained roads passable for emergency vehicles. Clay works great for dry, sandy conditions, but it is a mess when it gets wet. We are having mud issues with the roads that are in our Maint. System so I know you guys are having a rough time. I do have sympathy for I as well, live on a non-Maintained road and have to deal with the problems of that as well.

Sorry for my delayed response to your email, however, I took a little time off. I have reviewed our records and discovered that Springfield Road is a non-county maintained road. This means that the Board of County Commissioners (BCC) have not accepted this road into our maintenance system that would provide it routine maintenance. With that said, the BCC has directed staff to keep non-maintained roads with public right-of-way passable to emergency vehicles. I am copying our Maintenance Area 3 staff on this email. By copying them, I am requesting that they review this road and ensure it is passable to emergency vehicles. They will contact you with their findings.
