RE: Mowing in the Tavares area

Dear Mr. Thompson:

Based on a recent meeting we held with our staff and subsequent discussions, I offer the following information to clarify mowing responsibilities of certain roads in the Tavares area:

County Drive (3944)

County Drive is a County maintained road extending from SR-19 to Mansfield Road and is included in the County's program to mow every five (5) weeks.

Dead River Road (4140)

Dead River Road is a County maintained road extending from the end of County maintenance to SR-19 and is included in the County's program to mow. The sidewalk area on the south side of Dead River Road from Captain Haynes Road to SR-19 will be mowed every three (3) weeks. The north side of Dead River Road from Captain Haynes Road to SR-19 and the remaining areas where there is no sidewalk will be mowed every five (5) weeks. Note: It appears the sidewalk area on the north side of Dead River Road from Cove Road to Squibb Park is being mowed by the subdivision/HOA and is not included in the County's program to mow at this time.

Dora Avenue (4554)/CR-19A

Dora Avenue/CR-19A is a County maintained road extending from Old Highway 441 to US-441 and is included in the County's program to mow every five (5) weeks. Effective immediately, per request by the City of Tavares, Dora Avenue from Old 441 to David Walker Drive will be included in the City's program to mow every two (2) weeks. The remaining section of road is included on the County's program to mow every five (5) weeks.

Captain Haynes Road

Captain Haynes Road is City maintained road extending from Woodlea Road to Dead River Road and is included in the City's program to mow every two (2) weeks.

Lakeshore Drive (3960)

Lakeshore Drive is a County maintained road extending from Dora Avenue to Old Highway 441 and is included in the County's program to mow every five (5) weeks.
