The Department has approved a traffic signal to be installed at the intersection US 27/441 and Fennell Boulevard in conjunction with the construction of a hotel and shopping center pending final permit approval. We found that a traffic signal can be justified at this location based on the projected volumes from the proposed development.

The following are Lake County Public Works' comments regarding the above mentioned projects.

Signalization plans for 60% Submittal

Sheet T-2:

- ❖ Change detector pay item number's 660-1-101 and 102 to pay item # 660-1-109. Type 9, 2 channels, SS, RM detectors 8 each.
- Please revise the tabulation of quantities under the bid item number

Please add the following verbiage to General Notes Sheet T-3:

- * The contractor shall be responsible for acquiring the electric permit, and to coordinate application for power with the Town of Lady Lake.
- . Opticom preemption shall be used when emergency preemption is requested, and shall include all equipment and timings fully operation and functional.

Sheet T-4

- The side street phase timing operations should be changed to a protected/permissive left turn movement. Permissive movement on 6 lane highway presents safety issues.
- SOP diagram missing, please include SOP # 8 diagram in plans.
- Please revise controller timing plan as required.
- Yellow clearance should be 4 seconds on all movement.
- Maximum green times should be as follows;

Phases 2 and 6 - 60 secs

Phases 1 and 5 - 15 secs

Phases 3 and 7 - 15 secs

Phases 4 and 8 – 20 secs
