Good afternoon Gregory,

The County has an upcoming Wings and Wildflower event scheduled for the first of October. There are certain roads that are mapped for the event. We would like to reduce the mowing along these roads to only include one pass with the batwing mower to create a 8-12' wide pass along the edge of pavement. We would also like the decks raised to provide a 6-8" cut. These revised mowing standards are only applicable to the roads listed below and for the mowing cycles beginning 8/17 and 9/14. The regular mowing standards will apply for the 10/12 mowing cycle.

Please adjust the mowing as outlined above on the following roads:

- CR 445A
- CR 445
- CR 42
- CR 439
- CR 44A
- CR 46A
- CR 44
- CR 561
- CR 455
- CR 48
- CR 470
- CR 474
