Modica & Associates, Inc. reviewed the above referenced project site located on and adjacent to County Road 437 in Sections 7, 18, 19, 30, Township 19 South, and Range 28 East and Sections 25 and 36, Township 19 South, and Range 28 East in Lake County, Florida, for the purpose of preliminarily determining potential impacts of the proposed project on archaeological, historical and cultural resources.

The majority of the private properties which adjoin County Road 437 and the associated right-of-way consist of low-density single family residential properties and businesses such as numerous plant nurseries, Publix Super Market, CVS Pharmacy, and Circle K. Community facilities identified within or in close proximity to the project corridor include Sorrento Christian Center, Sorrento Elementary School, New Hope Missionary Baptist Church, First Baptist of Sorrento, Christ Community Fellowship, Bible Way Baptist Church, and East Lake County Library. These facilities are depicted on the enclosed Cultural Resources Map (Appendix A).

The Florida Department of State, Division of Historic Resources (DHR), State Historic Preservation Office (SHPO) was contacted on July 27, 2016 in an effort to identify historic properties within the proposal's area of potential effect (**Appendix B**). Modica & Associates received a response to this request on August 17, 2016 determining that the project area has not been surveyed for archeological or historical properties, but is in an area favorable for these resources. Therefore, SHPO was unable to provide a written determination to our request and recommended that the project area be subject to a professional cultural resources assessment survey (**Appendix C**). It is recommended that this be completed once the extent of the final project site has been decided.







The Florida State Historic Preservation Officer reviewed the referenced project for possible effects on historic properties listed, or eligible for listing, on the *National Register of Historic Places*. The review was conducted in accordance with Section 106 of the *National Historic Preservation Act of 1966*, as amended, and its implementing regulations in *36 CFR Part 800: Protection of Historic Properties*.

A review of the Florida Master Site File indicates that the project area has not been surveyed for archaeological and historical properties. Since conditions in the area are favorable for the presence of these kinds of resources, we request that the project area be subjected to a professional cultural resources assessment survey. The resultant survey report should conform to the provisions of Chapter 1A-46, *Florida Administrative Code*, and should be sent to our office upon completion. The report will help us complete the Section 106 review process and provide concurrence on federal determinations of effect, and recommend any necessary avoidance or mitigation measures.

The Division of Historical Resources cannot endorse specific archaeological or historic preservation consultants.
