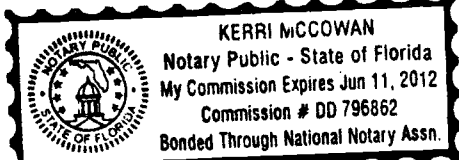

The ERP application is for construction of a surface water management system for a 78.68-acre road construction project known as Hartwood Marsh Road, Phase II.

tive hearing. All timely filed written objections will be presented to the Board for consideration in its deliberations on application prior to the Board taking action on the application.
