Standard General and Standard ERP Permit Applications

ASO Corporation, John Macaskill, 300 Sarasota Blvd., Sarasota, FL 34240, application #40-069-121963-1. The project is located in Lake County, Section 20, Township 22 South, Range 25 East. The ERP application is for construction of a surface water management system for a 4.23-acre commercial development known as International Sterilization Laboratories Master Site Plan - Phase One.

Red Jacket Development Group, Clay Frankel, 625 Waltham Ave., Orlando, FL 32809, application #40-069-122145-1. The project is located in Lake County, Section 36, Township 20 South, Range 25 East. The ERP application is for construction of a surface water management system for a 51.61-acre residential development known as Whispering Hills.

Lake County Department of Public Works, c/o James A. Stivender, Jr., P.E., 437 Ardice Avenue, Eustis, FL 32726, application #40-069-114354-3. The project is located in Lake County, Sections 9 & 10, Township 23 South, Range 26 East. The ERP application is for construction of a surface water management system for a 10.75-acre road widening project known as Hartwood Marsh Road - Phase I, Pond 2.

The project is located in Lake County, Section 33, Township 19 South, Range 27 East. The ERP application is for construction of a surface water management system for a 1.52-acre commercial development known as Veranda Parking Expansion. The receiving waterbody is Sunset Lake.

The file(s) containing the permit application(s) are available for inspection Monday through Friday, except for District holidays, 8:00 a.m. to 5:00 p.m. at the District's Headquarters, 4049 Reid St., Palatka, Florida, 32177-2529. You may also view files at one of the District's Service Centers, but you should call Service Center staff in advance to make sure that the files are at a specific Service Center. Additionally, most permit application file documents can be viewed online at <https://permitting.sjrwmd.com>. To obtain information on how to find and view permit application file documents, go to the HELP tab in E-Permitting and click on FAQ and then follow the directions provided under "How to find a Technical Staff Report (TSR) or other application file documents."

The decision on Standard General and Standard permit applications will be made at the District's Service Center where the application is processed, unless the application is upgraded to an Individual permit as explained below. A substantial objection to a Standard General or Standard permit application must be made in writing and filed with (received by) the Director of Regulatory Information Management, 4049 Reid St., Palatka, Florida, 32177-2529, or by e-mail at applicationsupport@sjrwmd.com, within 14 days of notification of the application. Please include either the Permit Application number or the Project Name in the objection. Notification of the application is either the fifth day after the date on which the written notice is deposited in the U.S. mail (for those persons who receive actual notice by U.S. mail), the day the notice is emailed (for those persons who receive actual notice by email), or the date the notice is published in the newspaper (if actual notice is not provided by U.S. mail or email). A "substantial objection" means a written statement directed to the District that identifies the objector, concerns hydrologic or environmental impacts of the proposed activity,

and relates to applicable rule criteria. A timely substantial objection will cause the Standard General or Standard permit application to be considered an application for an Individual permit. If the District receives a timely substantial objection from you, then you will receive written notice of the District's intended decision on the permit application.

Please note that decisions on Individual permit applications will be made either by the District's Executive Director or designee (for those applications which are recommended for approval) or by the District's Governing Board (for those applications which are recommended for denial). For Individual permit applications, you are advised to notify the District within 14 days of notification of the application(s) if you have questions, objections, comments, or information regarding the activity proposed in the permit application. If you make a written request to the District for additional information regarding a specific permit application, you will be provided an opportunity to obtain the available information. Please note that filing a written objection does not entitle you to a Chapter 120, Florida Statutes, administrative hearing.

Notice of intended (proposed) District Decision will be provided to persons who have requested individual notice. A request for individual notice of intended (proposed) District Decision on the application must be received by the District's Director of the Division of Regulatory Information Management prior to the date the notice of intended (proposed) District Decision is generated.
