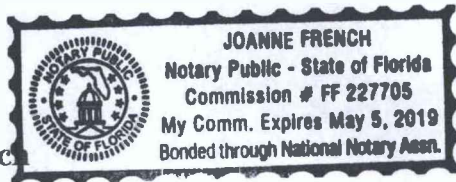

The project is located in Lake County, Section: 34, Township: 22 South, Range: 26 East, and includes 3.1171 acres. The Environmental Resource Permit application is for construction of a stormwater management system to serve a project known as CubeSmart @ Hancock Road.

for additional information regarding a specific permit application, you will be furnished with the information available at that time. Please note that filing a written objection does not entitle you to a Chapter 120, Florida Statutes, administrative hearing.

A request for Individual Notice of District Decision or Intended District Decision on the application must be received by the District's Office Director, Office of Business and Administrative Services prior to the date such Notice is generated.
