**King's Ridge, Clermont, Lake County, Florida**

Dear Mr. Carlie:

The purpose of this letter is to notify you that the permit holder of the above referenced permits will rely on three (3) recent extension authorizations. The first extension is the two-year extension of the expiration dates as granted by House Bill 503 for certain development orders, permits and other authorizations. In order to receive the extension, the developer must provide the local government written notification by December 31, 2012. Please accept this letter as proof of said required notification.

The other two extensions are authorized pursuant to Section 252.363, Florida Statutes, which provides in part, that permits and other authorizations are extended for the length of the state of emergency issued and an additional six months thereafter. The second extension is associated with State Emergency Order 12-140 for Tropical Storm Debby which extends and tolls certain time-frames associated with specified permits and development orders as part of the Governor's state of emergency declaration. The extension period is six (6) months in addition to the sixty (60) days tolled period. The third extension is associated with State Emergency Order 12-199 for Tropical Storm Isaac which extends and tolls certain time-frames associated with specified permits and development orders as part of the Governor's state of emergency declaration. The extension period is six (6) months in addition to the sixty (60) days tolled period.
