

- 1. A person whose substantial interests are or may be determined has the right to request an administrative hearing by filing a written petition with the St. Johns River Water Management District (District), or may choose to pursue mediation as an alternative remedy under sections 120.569 and 120.573. Florida Statutes, before the deadline for filing a petition. Choosing mediation will not adversly affect the rights to a hearing if mediation does not result in a settlement. The procedures for pursuing mediation are set forth in sections 120.569 and 120.57, Florida Statutes, and rules 28-106.111 and 28-106.401-.405, Florida Administrative Code. Pursuant to District rule 40C-1.511, Florida Administrative Code, the petition must be filed at the office of the District Clerk at District Headquarters, Highway 100 West, Palatka, Florida 32178-1429 within nineteen (19) days of the District depositing notice of its intent in the mail (for those persons to whom the District mails actual notice) or within fourteen (14) days of newspaper publication of the notice of its intent (for those persons to whom the District rule 40C-1.421, Florida Administrative Code.
- 2. If the Governing Board took action which substantially differs from the notice of intent to grant or deny the permit application, a person whose substantial interests are or may be determined has the right to request an administrative hearing. Pursuant to District rule 40C-1.511, Florida Administrative Code, the petition must be filed at the office of the District Clerk at District Headquarters, Highway 100 West, Palatka, Fiorida 32178-1429, within nineteen (19) days of the District depositing notice of final agency action the the mail (for those persons to whom the District mails actual notice) or within fourteen (14) days of newspaper publication of the notice of its final agency action (for those persons to whom the District does not mail actual notice). Such a petition must comply with District rule 40C-1.521, Florida Administrative Code.
- 3. A substantially interested person has the right to a formal administrative hearing pursuant to Sections 120.569 and 120.57(1), Florida Statutes, where there is a dispute between the District and the party reqarding an issue of material fact. A petition for formal hearing must comply with the requirements set forth in Section 40C- 1.521(2), Florida Administrative Code.
- A substantially interested person has the right to an informal hearing pursuant to Sections 120.569 and 120.57(2), <u>Florida Statutes</u>, where no material facts are in dispute. A petition for an informal hearing must comply with the requirements set forth in Section 40C- 1.521(2), Florida Administrative Code.
- 5. A petition for an administrative hearing is deemed filed upon delivery of the petition to the District Clerk at the District headquarters in Palatka, Florida. (Section 40C-1.013, Florida Administrative Code)
- 6. Failure to file a petition for an administrative hearing, within the requisite time frame shall constitute a waiver of the right to an administrative hearing. (Section 40C-1.511, Florida Administrative Code)
- 7. The right to an administrative hearing and the relevant procedures to be followed are governed by Chapter 120, Florida Statutes, and Chapter 40C-1, Florida Administrative Code.
- 8. An applicant with a legal or equitable interest in real property who believes that a District permitting action is unreasonable or will unfairly burden the use of his property, has the right to, within 30 days of receipt of notice of the District's intent to grant or deny a permit application, apply for a special master proceeding under section 70.51, <u>Florida Statutes</u>, by filing a written request for relief at the office of the District Clerk located at District headquarters, Highway 100 West, Palatka, Florida 32178-1429. A request for relief must contain the information listed in subsection 70.51(6), Florida Statutes.
- A timely filed request for relief under section 70.51, <u>Florida Statutes</u>, tolls the time to request an administrative hearing under paragraph no. 1 or 2 above. (Paragraph 70.51(10)(b), <u>Florida Statutes</u>) However, the filing of a request for an administrative hearing under paragraph no. 1 or 2 above waives the right to a special master proceeding. (Subsection 70.51(10)(b), <u>Florida Statutes</u>)
- 10. Failure to file a request for relief within the requisite time frame shall constitute a waiver of the right to a special master proceeding. (Subsection 70.51(3), Florida Statutes)

- 11. Any substantially affected person who claims that final action of the District constitutes an unconstitutional taking of property without just compensation may seek review of the action in circuit court pursuant to section 373.617, Florida Statutes, and the Florida Rules of Civil Procedures, by filing an action in circuit court within 90 days of rendering of the final District action, (Section 373.617, Florida Statutes).
- 12. Pursuant to Section 120.68, Florida Statutes, a person who is adversely affected by final District action may seek review of the action in the district court of appeal by filing a notice of appeal pursuant to the Florida Rules of Appellate Procedure, within 30 days of the rendering of the final District action.
- 13. A party to the proceeding before the District who claims that a District order is inconsistent with the provisions and purposes of Chapter 373, Florida Statutes, may seek review of the order pursuant to Section 373,114, Florida Statutes, by the Florida Land and Water Adjudicatory Commission, by filing a request for review with the Commission and serving a copy on the Department of Environmental Protection and any person named in the order within 20 days of adoption of a rule or the rendering of the District order.
- 14. For appeals to the District courts of appeal, a District action is considered rendered after it is signed on behalf of the District, and is filed by the District Clerk.
- 15. Failure to observe the relevant time frames for filing a petition for judicial reviews described in paragraphs #11 and #12 or for Commission review as described in paragraph #13 will result in waiver of that right to review

## General Description OF APPLICATION NO.4-069-0326AM8-ERP:

This application is for authorization to modify the surface water management system with construction of a 40.07-acre residential development within the master drainage system known as Manchester @ Kings Ridge. The surface water management system includes two proposed dry, retention ponds, one existing dry retention pond, and stormsewer system.

Authority: chapter 373 F.S.; chapter 40C-4.041(1)(2)(b)2 F.A.C.

**Existing Land Use:** Abandoned citrus grove

## **Staff Comments:**

The project is located approximately 3 miles south of Clermont on the east side of US Highway 27 (See Attachment A). The site is located within the Ocklawaha River Hydrologic Basin.

A stormwater permit #42-069-1062 was issued for Phase I of the Kings Ridge development on June 28, 1995. This permit authorized the construction of a stormwater system consisting of a 17.85-acre project including an entrance road, model homes, and sales center. A standard general permit (40-069-0196) was issued for Phase II, 101.35 acres. Phase II of the project consisted of 136, single-family lots, 7 holes of a 18-hole golf course, three dry-retention ponds and two, existing, dry retention ponds (two depressional areas), and one temporary dry retention pond. Phase III of the project (4-069-0326) was permitted for a residential development with 145 lots and the remaining 11 holes of the golf course. The surface water management system for Phase III includes 299.27 acres (38 acres of subdivision, and 261.27 of mass grading and 10 retention ponds). Subsequently, Permits 4-096-0326M through 4-096-0326M7 have been issued for the site for additional phases of development or to modify permitted systems.

This application is for the construction of a new 40.67-acre, single-family, residential subdivision within the Kings Ridge master drainage system to be known as Manchester at Kings Ridge . The system includes two, proposed, dry-retention ponds, one existing dry retention pond, and 181 lots.

Under the existing conditions, runoff is discharged to a landlocked drainage basin onsite. Under the post-development condition the site is designed to retain the entire runoff generated by 25-year, 96-hour storm event on-site (In the analysis of the storm events, infiltration during the storm event was assumed), and recover the total volume within 14 days. The system is also designed to provide the required water quality treatment, and recover this volume within 72 hours following the storm event. The proposed construction has no encroachment to a floodplain area. The project is located within the Oklawaha River Hydrologic Basin. The design, as proposed, meets the applicable Ocklawaha Basin criteria. The applicant has demonstrated that the proposed system will provide treatment and recovery of the required pollution abatement volume, and volume storage of runoff, pursuant to chapter 40C-42, 40C-41, and 40C-4, F.A.C.

The proposed project site consists of either cleared grassed areas or planted pine trees. There are no wetlands within the project area. The proposed project will have no unacceptable adverse secondary and cumulative impacts to wetlands, water quality, and upland habitat for aquatic and wetland dependent fish or wildlife "listed" as endangered, threatened, or of special concern. Staff has determined that the proposed project is consistent with the wetland review criteria in sections 12.2 - 12.3.8, A.H./MSSW, ERP.

This project, as proposed, is consistent with the objectives and criteria of the District set forth in 40C-4.301, 40C-4.302, 40C-41, and 40C-42, F.A.C.




# **Other Conditions:**

In compliance with your request for notice of applications received in Lake County, enclosed is a copy of Section C - Environmental Resource Permit Notice of Receipt of Application, Section A of the application, and a location map for each permit application applied for within the above referenced county.

Permit applications beginning with a "42" followed by an "I" (for example, 42-109-0001AI) or a "4" are Individual permit applications that require the District Governing Board to act on (approve or deny) the application. For these applications, you are advised to notify the District within 14 days of receipt of this letter of any questions, objections, comments or information regarding the proposed system. Those who file a written request for further information regarding the permit application will be furnished the information requested prior to the Governing Board meeting at which the application will be considered.

Permit applications beginning with "42" (without an "I" in the number) or "40" are General permit applications that are issued from the Service Centers. For these applications, any substantial objections to the permit application must be made in writing and filed with (received by) the District Clerk, located at P.O. Box 1429, Palatka, Florida, 32178-1429, on or before 14 days from date of posting of the notice of receipt of application. The posting date is shown on the bottom of Section C in the shaded block designated as "For Agency Use Only", and adjacent to "Date to be posted". A substantial objection means a written statement directed to the District which identifies the objector, concerns hydrologic or environmental impacts of the proposed activity and relates to applicable rule criteria. If a substantial objection is received, the procedures applicable to an Individual permit application will be followed. The receipt of a substantial objection will entitle you to an individual notice prior to the Governing Board meeting at which the application will be considered.

Permit applications beginning with "400" are Noticed General Permit applications. For these applications, any objections as to whether the proposed activity qualifies for the requested noticed general permit must be made in writing and filed with (received by) the District Clerk, P.O. Box 1429, Palatka, Florida, 32178-1429, on or before 14 days from date of posting of the notice receipt of application. The posting date is shown
