## Re: 7-Eleven @ S. R. 50 and Hancock Road, Lake County, FL SE corner of S. R. 50 and Hancock Road Letter of Modification - SJRWMD Permit No. 42-069-67971-1

To Whom It May Concern:

This is a letter of modification of the existing SJRWMD permit # 42-069-67971-1. The project is located within the City of Clermont limits, on the SE corner of State Road 50 and Hancock Road, Lake County, Florida.

The existing permitted overall site has a total of 5.63 acres including 3.96 acres of impervious area. The proposed modification will include the construction of a road, connecting S. R. 50 and the commercial project known as Hancock Commons, as well as the redesign of the existing retention pond area. The existing calculations are indicating the proposed road was included within the 2.36 acres (site basin) including a total of 75% of impervious area. Walls will be constructed to provide for additional storage to make up for the encroachment issued by the road crossing.

Due to this modification there will be no increase of the project area or of the impervious area nor a reduction of the stormwater treatment capability of the system.

Please see attached existing SJRWMD permit, construction plans and modified drainage calculations.
