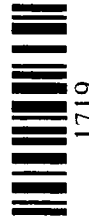

**Describe in general terms the proposed project, system, or activity.**

The project involves construction of South Hancock Road between US 27 to Hartwood Marsh Road as a four-lane divided urban roadway with bicycle lanes, sidewalk and a multipurpose trail. Storm water management will be provided in three proposed detention ponds. A wet pond, Pond 1, will discharge to Lake Louisa via the wetland south of South Hancock Road and east of US 27. A dry pond, Pond 2, will discharge to an unnamed lake south of Hartwood Marsh Road and west of Hancock Road. A portion of South Hancock Road at the north end at Hartwood Marsh Road will be treated in proposed Hartwood Marsh Road Pond 2.
