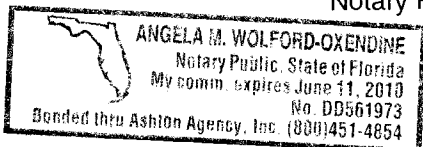

The St. Johns River Water Management District has received the application(s) for Environmental Resource Permit(s) from:

Galatic Investments, Inc., 14 Glen Ridge Lane, Pittsburgh, PA 15243, application #40-069-26608-6. The project is located in Lake County, Section 21, Township 22 South, Range 25 East. The ERP application is for construction of a surface water management system for a 1.25-acre commercial development known as Green Valley, Lot 1 (aka Green Valley Commons).

Lake County Department of Public Works, 437 Ardice Avenue, Eustis, FL 32726, application #40-069-115314-1. The project is located in Lake County, Sections 12 & 13, Township 20 South, Range 24 East. The ERP application is for construction of a surface water management system for a 15.05-acre project known as the Hollendel Road Regional Stormwater Pond.

Only those persons whose substantial interests are affected by the application and who file a petition meeting the requirements of Sections 120.596 and 120.57, Florida Statutes, and Chapter 28-106, Florida Administrative Code, may obtain an Administrative hearing. All timely filed written objections will be presented to the Board for consideration in

its deliberations on application prior to the Board taking action on the application.
