# FIRST AMENDMENT TO RIGHT-OF-WAY CONVEYANCE AGREEMENT

(Town Center - Schofield Road, Porter Road, Valencia Parkway)

(Capitalized terms which are not specifically defined in this First Amendment are defined in and shall have the same meaning as in the Original Agreement)

This First Amendment (the "First Amendment") to Right-of-Way Conveyance Agreement, is made and entered into by and among ORANGE COUNTY, a charter county and political subdivision of the State of Florida, whose address is c/o Orange County Administrator, Post Office Box 1393, Orlando, Florida 32802-1393 (the "County"); FOX HEARTLAND, LLC, a Florida limited liability company, whose office address is 500 South Australian Avenue, Suite 710, West Palm Beach, Florida 33401 ("Fox Heartland"); FOX KAY, LLC, a Florida limited liability company, whose office address is 500 South Australian Avenue, Suite 710, West Palm Beach, Florida 33401 ("Fox Kay"); FOX COMMON, LLC, a Florida limited liability company, whose office address is 500 South Australian Avenue, Suite 710, West Palm Beach, Florida 33401 ("Fox Common") (collectively "Fox Entities"); and ISLAND TREE, LLC, a Florida limited liability company ("Island") whose office address is 500 South Australian Avenue, Suite 710, West Palm Beach, Florida 33401. Fox Entities, Island, and County are sometimes referred to herein as the "Parties" to this First Amendment.

### WITNESSETH:

WHEREAS, the Parties entered into that certain Right-of-Way Agreement approved by the Orange County Board of County Commissioners ("BCC") on March 8, 2011 and recorded in Official Records Book 10184, Page 1403, in the Public Records of Orange County, Florida (the "Original Agreement"); and

WHEREAS, the Fox Entities and Island were unable to convey the Trust Parcels, as described in the Original Agreement, and the Island Parcels to the County within the extended

time frame allowed in the Original Agreement because of an unavoidable delay in obtaining subordination of a utility easement held by AT&T Corporation (the "Utility Easement") and the need for sub-surface investigation of a portion of the Trust Parcels; and

WHEREAS, the Parties would like to proceed with conveyance to the County of only the Island Parcels at this time; and

WHEREAS, E. Allen Bottorff, II has replaced Helene Loiselle as one of the Co-Trustees under the Amended Land Trust Agreement; and

WHEREAS, the Parties desire to amend certain terms and provisions of the Original Agreement as set forth below; and

WHEREAS, in all other respects the terms of the Original Agreement shall remain unchanged and in full force and effect.

NOW, THEREFORE, the Parties agree as follows:

- **Section 1. Recitals.** The above recitals are true and correct and are incorporated herein by this reference.
- Section 2. Conveyance of Land to County by Fox Entities and Island. Section 2(a) of the Agreement is hereby deleted and replaced with the following:
  - (a) Conveyed Lands. Within sixty (60) days from the Effective Date of this First Amendment, Island shall convey to the County marketable fee simple title to the Island Parcels, as depicted and described in Exhibits B-1 and B-2 of the Original Agreement. The parties agree that the conveyance of the Trust Parcels, as depicted and described in Exhibits A-1, A-2 and A-3 of the Original Agreement, shall occur within 120 days from the Effective Date of this First Amendment. In the event the conveyance of the Trust Parcels does not occur within the aforesaid 120 days, the Director of the Administrative Services Department, or his/her designee, may grant an extension of up to an additional 120 days for the conveyance to take place. The County agrees to diligently review the proposed conveyances such that any comments or objections can be resolved within the time frames for conveyance as stated herein.
- **Section 3.** Notice. Section 6 of the Original Agreement is hereby deleted and replaced with the following:
  - 6. <u>Notice</u>. Any notice delivered with respect to this Agreement shall be in writing and shall be deemed to be delivered (whether or not actually

Section 4. Covenants Running with the Land. The Original Agreement and this First Amendment shall run with the Trust Parcels and the Island Parcels and shall be binding upon and shall inure to the benefit and detriment of the heirs, legal representatives, successors, and assigns of the owners of these parcels and any person, firm, corporation, or other entity that may become the successor in interest to the Trust Parcels and the Island Parcels. Notwithstanding the foregoing, however, the authority under Section 4.(b) of the Original Agreement to instruct the County to make deductions from its road impact fee account shall remain with Fox Heartland as the owner of the road Impact Fee Credit Account, unless expressly assigned in writing by Fox Heartland to another party.

- **Section 5.** Recordation of First Amendment. An executed original of this First Amendment shall be recorded, at the expense of Fox Heartland, in the Public Records of Orange County, Florida within thirty (30) days of the Effective Date.
- Section 6. Applicable Law. This First Amendment and the provisions contained herein shall be construed, controlled, and interpreted according to the laws of the State of Florida.
- **Section 7.** Counterparts. This First Amendment may be executed in up to 8 counterparts, each of which shall be deemed to be an original, but all of which together shall constitute one and the same instrument.
