### FOREST DEVELOPMENT ROAD COOPERATIVE AGREEMENT U.S. FOREST SERVICE AND LAKE COUNTY, FLORIDA

#### SCHEDULE A

April, 1990

The Cooperator and the Forest Service agree that maintenance, to include 20' foot wide pavement, and drainage over the existing roads and jurisdiction of the following road segments is the responsibility of Lake County, Florida:

- Forest Service Road 540, also known as Deerhaven Road, County No. 5-9097, from HIghway 42 to the entrance to Deerhaven Campground in Section 1, Township 17 South, Range 28 East.
- Forest Service Road 572, also known as Kismet Road, County No. 5-9081, from County Road 445 to South Street in Subdivision in Section 16, Township 17 South, Range 27 East.
- Forest Service Road 546, also known as Also ROad, County No. 5-9588, south from State Road 40, 2 1/2 miles then east 1 1/2 miles to end.
- 4. Lightfoot Road, County No. 5-9685, northwesterly from State Road 40, 1 1/4 miles to an intersection and then west approximately 1/8 mile to a dead end.
- 5. Blue Creek Lodge Road, County No. 5-9883, north from State Road 40 to a dead end at Blue Creek.
- 6 Lake George Road, County No. 5-9884, from Blue Creek Lodge Road, County No. 5-9883 to the public boat ramp on Lake George.
- Forest Service Road 549, also known as 3rd Street, County No. 5-9689, south from State Road 40 approximately 1 1/8 miles to end.
- 8. Dexter Road, County No. 5-9589, east from Alco Road, County No. 5-9588 approxiamtely 1 1/4 miles to end.
- 9. Forest Service Road 550, also known as Railroad Grade Road, County No. 5-9277, southwesterly from State Road 19 to the Marion County Line.
- 10. Forest Service Road 538, also known as Paisley Road, from State Route 445 south to County Road 8787. Total length of 6.4 miles.
- 11. Forest Service Road 540-B which is off Forest Service Road 540 (Deerhaven Road). At Intersection (Section 1, Township 17 South, Range 28 East), west to end of road. Total length is 1 mile.



12. Forest Service Road 540-C which is off Forest Service Road 540 (Deerhaven Road). At intersection (Section 1, Township 17 South, Range 28 East), west to end of road. Total length is 0.55 miles.

## FOREST DEVELOPMENT ROAD COOPERATIVE AGREEMENT U.S. FOREST SERVICE AND LAKE COUNTY, FLORIDA

#### Schedule A Amendment

This following item is an addition to the revised Schedule A completed in April 1990:

13. The Forest Service (Ocala National Forest, Seminole Ranger District) will permit clay to be extracted, hauled and placed on public county roads by Lake County Division of Development and Public Works. The existing clay pit is located in N.E. 1/4 of Section 35, Township 17 South, Range 26 East, Marion County, north of State Road 42 on National Forest Land.

Lake County will accept responsibility of reclamation of the pit, and maintenance of the entrance road and pit during the operational period. This work will be completed according to the Forest Service specifications.

All National Forest survey monuments and witness trees will be protected, and no trees will be cut until notification and permission is given by the Forest Service.

The Forest Service holds the right to access, gather, and haul clay on Forest Service roads on the Ocala National Forest.

On a fiscal year basis from October 1 to September 30, Lake County will maintain records of the amount of clay (cubic yards) that Lake County removed from the described pit. This information will be provided in writing to the District Ranger in October of each year.

#### Schedule A Amendment

The following item is an addition to the revised Schedule A completed in April 1990, Road Maintenance Agreement. Roads to be maintained by grading only at an interval of six times per year.

- 14. Forest Service Road 539. The distance is 2.1 miles from County Road 42 to Forest Service Road 540-2, located in Section 3 and 11, Township 17 South, Range 28 East. Road to be maintained by grading only at an interval of six times per year.
- 15. Forest Service Road 540-2. The distance is 0.4 miles from Forest Service Road 539 to terminus of unimproved road. Road to be maintained by grading only at an interval of six times per year.

- Work shall conform to the requirements of Section 611, and as noted on the plans. All pit development and related work is subsidiary to and paid for under Pay Item 203(10).
- Clear and grub as per requirements of Specification 201, using slash treatment Method 4.
- Ņ Excavation of material from pit: The material shall be removed from the pit in accordance with the stakes set by the Engineer and NO material shall be removed until the Engineer has set the stakes. Material pits shall be excavated neatly to the depth of existing pit. Where the bottom is above the normal water table it shall be sloped to drain as directed by the Engineer. The material shall be removed from

# 4. Restoration:

- A. Shape pit side slopes a minimum of 3:1, except working clay face shall be left vertical.
  B. Seed, fertilize and mulch all areas disturbed by this project as per requirements of Specification 625.
- C. Upon completion of hauling, access road shall be graded and any necessary drainage work done to prevent environmental damage.
- D. Upon completion of excavation from wet pit all berms shall be removed.
