

CO-03 includes additional Lake County requested pedestrian safety devices to be added to the N Hancock Rd crossing at the Minneola High School main entrance. Final project completion is subject to delivery, installation and acceptance of noted additional pedestrian safety devices.

The actual Revised Final Completion Date shall be published by executed CO-03.
