Request approval of a Release of Liability requested by Orlando Health for the donation of a Handtevy (pediatric resuscitation) System. There is no fiscal impact.

BACKGROUND SUMMARY: On May 5, 2020, the Board of County Commissioners (Board) approved acceptance of a Handtevy System from Orlando Health through South Lake Hospital. Orlando Health is requesting a signed Release of Liability for the donation. The release states that the condition of the product provided is "as is," all warranties are transferred to the Board and any claim or issues shall be handled directly between the warranty provider and the Board.

The Office of Emergency Medical Services acknowledges the "as is" condition of the donated items.

SUBJECT: Donation of a Handtevy System from Orlando Health Systems through South Lake Hospital

RECOMMENDATION/REQUIRED ACTION:

Request approval to accept the donation of a Handtevy System (a pediatric resuscitation system) donated from Orlando Health Systems through South Lake Hospital. There is no fiscal impact.

BACKGROUND SUMMARY: The Office of Emergency Medical Services (EMS) is requesting approval to accept a donation of a Handtevy System. This donation, including the training, is valued at approximately \$34,000. Per Lake County Donation Policy LCC-98, donations valued at \$25,000 or more shall be brought to the Board of County Commissioners for acceptance or rejection.

While all calls for medical assistance can generate a level of stress, incidents involving pediatric patients can be especially difficult. In calendar year 2019, EMS responded to 1,168 calls for service where the patient was under the age of 14 years old. Handtevy is a pediatric resuscitation system proven to save lives and reduce errors. This system is designed to give clinical teams rapid access to lifesaving dosing, equipment and drip information while documenting every critical action.

This donation includes 25 Handtevy pediatric bags, 30 guide sets, software, and training. Staff requests approval of the donation for implementation to assist in improving treatment of children patients and ultimately saving lives.
