All furnishings shall be in strict compliance with the latest codes, standards and practices.

Misc. Items to be noted:

- Erect-A-Step (6 step) or approved equal must (meet or exceed the specifications)
- Aluminum Ship Steps, 24" Tread width, 4" Tread Depth.
- Aluminum powder coated handrails.
- OSHA Compliant
- Must submit photo / catalog cut sheet of product for approval.
- See attached picture/ detail sheets for reference.
- No installation required.

1.02 SUBMITTALS:

- A. Submit product data/specification to the Office of Parks and Trails for review and approval of all requested products.
- B. All products shall be inspected by the County for damage and chipped or marred finish. Contractor shall replace any damaged or rejected products at no conditional cost to the owner. The owner's representative may at his option authorize acceptance of chipped or scratched painted surfaces repaired by contractor at his own risk.

1.03 PRODUCT HANDLING:

- A. Deliver products to site in manufacturer's containers or packaging.

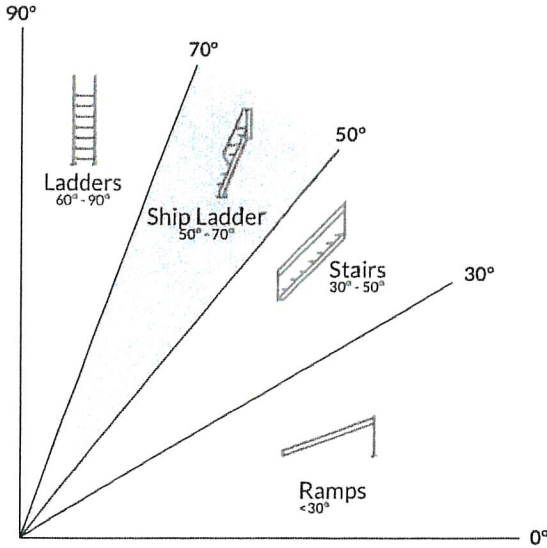

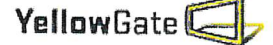
