QUESTIONS/RESPONSES

- Q1. The plans say posts spaced 10 foot apart, and 1 x 6 x 16 foot rails. The posts would need to be spaced 8 feet apart in order for the rails to work. Please clarify this. Thank you.
- **R1.** Yes, posts should be spaced 8 feet apart due to the specified top railing dimensions. The existing 2,700 feet of 4-wire fence that runs east to west (please see map) currently has some posts that are set at 14 foot spacing on average. We will need the contractor to set a 3.5 to 4 inch diameter post between each existing post prior to installing field fence. Each post shall be spaced at maximum of 8 feet to support the 16 foot fence boards.
- Q2. Can we use an equal to the wire that is in the specs. Red brand is just a label, and all other field fence in that spec will match the spec of the label Red Brand.
- R2. An approved equal will be fine, as long as the specifications are the same.
- Q3. Is there any way the vegetation could be pushed into the wooded area and left to eventually rot and disappear? Most of the job is light clearing and will require very little clearing if any. But some of the job is heavily wooded and will moderately affect our quote? Either way is fine just asking.
- R3. The County can coordinate with the contractor to identify 2 to 3 areas where any significant vegetation can be piled and will later be picked up by County staff.
- Q4. The 30-day deadline is a very short period for 6400 feet of fence. 60 or 90 days is more in line with that size job. The scope mentioned liquidated damages, so if 30 days is mandatory, what would the liquidated damages be, and we can figure it into our quote. We are a big company, with 12 crews, but that's an aggressive time frame for a job that size.
- R4. The County is willing to extend the 30 day deadline for completion to 60 days.
